An Act to Provide for the Exemption of Certain Lands belonging to or leased by The Grand Chapter of Alberta Order of Eastern Star from Taxation

(Assented to _____, 1964)

Preamble **W**HEREAS The Grand Chapter of Alberta Order of Eastern Star has presented a Petition praying for an Act to provide for the Exemption of certain lands belonging to it in the City of Lethbridge and leased from the Cities of Calgary and Edmonton to The Grand Chapter of Alberta Order of Eastern Star from assessment and taxation other than that relating to local improvements and that relating to minerals and it is expedient to grant the prayer of the said Petitioner:

THEREFORE, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

Exemption
from
taxation

1. The following properties, namely:
 - (a) Lands located at the City of Calgary, in the Province of Alberta, and described as follows:
 - (i) The North 110 feet of Lots 3 and 4, Block 71, Plan Calgary 4479P.
 - (ii) Lots 1 and 2 and those portions of Lots 3 and 4 lying South of the North 110 feet, Block 71, Plan Calgary 4479P.
 - (iii) Lots 5 to 8, Block 71, Plan Calgary 4479P.
 - (iv) Lots 9 and 10, Block 71, Plan Calgary 4479P.
 - (b) Lands located at the City of Lethbridge, in the Province of Alberta, and described as follows:
 - (i) Lots 1, 2 and 3 according to a Plan of record in the Land Titles Office for the Southern Alberta Land Registration District as Lethbridge 1855FS EXCEPTING thereout all mines and minerals.
 - (c) Lands located at the City of Edmonton, in the Province of Alberta, and described as follows:
 - (i) All that portion of unsubdivided River Lot 26 in Virginia Park, a Subdivision of the City of Edmonton, municipally described as:
 - 11106 76A Street
 - 11108 76A Street
 - 7621 111A Avenue

shall be exempt from assessment and taxation other than taxes relating to local improvements and taxes pertaining to minerals so long as they shall remain registered in the name of The Grande Chapter of Alberta Order of Eastern Star and be owned or leased by it and used by it for or in connection with charitable purposes.

Commence-
ment of Act

2. This Act comes into force on the day upon which it is assented to and upon so coming into force shall be deemed to have been in force at all times on and after the 31st day of December, 1963.
