## Explanatory Note

**1.** The Alberta Livestock and Livestock Products Act, R.S.A. 1955, c. 181, amended.

**2.** Section 3 (a) presently reads:

"3. The Lieutenant Governor in Council may make regulations providing for  
(a) the inspection, grading, packing and marking of livestock and livestock products,  
.....".

The new clause (a1) will be uniform with a similar provision in The Dairymen's Act.

**3.** Section 11, clauses (b) and (d) presently read:

"11. The Minister may by regulation  
.....  
(b) require the marking by veterinary inspectors of any livestock product of any specified standard,  
.....  
(d) prescribe  
(i) the manner in which veterinary inspectors shall mark any livestock product of any specified standard, and  
(ii) the device to be used for the purpose of marking livestock products and the design thereof,  
and  
.....".

**4.** Section 12, subsection (1) presently reads:

"12. (1) Any livestock product marked by a veterinary inspector pursuant to this Act shall be sold without restriction in every part of the Province."

**5.** Commencement of Act.

# BILL

An Act to amend The Alberta Livestock and Livestock  
Products Act

**H**ER MAJESTY, by and with the advice and consent of  
the Legislative Assembly of the Province of Alberta,  
enacts as follows:

**1.** *The Alberta Livestock and Livestock Products Act* is hereby amended.

**2.** Section 3 is amended by striking out clause (a) and by substituting the following:

- (a) the inspection, weighing, grading, packing and marking of livestock,
- (a1) the weighing, grading, sampling, testing and analysing of livestock products,
- (a2) the fees payable for services supplied by the Department of Agriculture pursuant to this Act or the regulations,

**3.** Section 11 is amended

- (a) as to clause (b) by striking out the words "by veterinary inspectors",
- (b) as to clause (d) by striking out subclause (i) and by substituting the following:
  - (i) the manner in which any livestock product or any specified standard shall be marked, and

**4.** Section 12, subsection (1) is amended by striking out the words "by a veterinary inspector".

**5.** This Act comes into force on the day upon which it is assented to.
