### **Explanatory Note**

This Bill will validate certain agreements entered into by the Town of Smoky Lake and The British American Oil Company Limited for the sale of a well to the Town and the leasing of a stand-by well to the Town.

# BILL

No. 149 of 1964

An Act to authorize and permit the Town of Smoky Lake to enter into certain Agreements with The British American Oil Company Limited

(Assented to \_\_\_\_\_, 1964)

**H**ER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Town of Smoky Lake Gas Utility Act.*"

2. Notwithstanding any provision of *The Town and Village Act*, or of *The Local Authorities Board Act*, or of *The Public Utilities Board Act*, or of *The Oil and Gas Conservation Act* affecting or relating to the purchase or lease of natural gas wells or the purchase or lease of natural gas rights by a town, the Town of Smoky Lake

(a) is hereby authorized and permitted and shall be deemed to have had the capacity to enter into that certain agreement dated the 1st day of March, 1964, between The British American Oil Company Limited, and the Town of Smoky Lake for the purchase by the Town of the well Edwand No. 1 and the natural gas rights in the Blairmore formation underlying Section 26, Township 60, Range 16, West of the Fourth Meridian, and

(b) is hereby authorized and permitted to and has capacity to enter into an agreement with The British American Oil Company Limited for the leasing by the Town of the well Edwand No. 2 and the natural gas rights in the Blairmore formation underlying Section 25, Township 60, Range 16, west of the Fourth Meridian.

3. Notwithstanding any provision of the Acts mentioned in section 2, the approval of the proprietary electors is not required regarding the agreements mentioned in section 2, nor to the issuance of any debentures required,

(a) to carry out the provisions of those agreements, and

(b) to cover the cost of drilling a stand-by well into the Blairmore formation underlying Section 26, Township 60, Range 16, West of the Fourth Meridian.

4. This Act comes into force on the day upon which it is assented to.
