An Act to Provide for the Exemption of Certain Land which is the Property of Sisters of Charity (Grey Nuns) of Alberta from Assessment and Taxation

(Assented to _____, 1965)

Preamble

WHEREAS the Sisters of Charity (Grey Nuns) of Alberta, being a body corporate incorporated by chapter 114 of the Statutes of Alberta, 1957, have presented a Petition praying for An Act to Provide for the Exemption of Certain Land belonging to the Sisters of Charity (Grey Nuns) of Alberta from Assessment and Taxation, other than that relating to local improvements and mines and minerals, and it is expedient to grant the prayer of the said Petitioner:

THEREFORE Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. Chapter 114 of the Statutes of Alberta, 1957, being An Act to Incorporate the Sisters of Charity (Grey Nuns) of Alberta is hereby amended by adding after section 13a the following section:

Exemption

13b. The following land, namely,

Lot (F) containing twenty-six and five hundredths (26.05) acres more or less, in the City of Edmonton, in the Province of Alberta, Canada, as shown on Sub-division Plan 776 N.Y. (Jasper Place N.W. 34-52-25-4)

Reserving unto Her Majesty all mines and minerals.

together with the buildings located thereon shall be exempt from assessment and taxation, except for local improvement taxes and taxes pertaining to minerals, so long as the same are owned and used by the Sisters of Charity (Grey Nuns) of Alberta for or in connection with the provision and facilities for divine worship, charitable purposes and the provision of educational and training facilities for young girls and young ladies seeking to devote their lives to the Sisterhood.

Commence-
ment of Act

2. This Act comes into force on the day upon which it is assented to and upon so coming into force shall be deemed to have been in force at all times on and after the first day of January, 1965.
