A Bill to amend The Local Authorities Board Act

Explanatory Note

1. The Local Authorities Board Act, which is chapter 46 of the Statutes of Alberta, 1961, is to be amended by this Bill.

2. Section 70 is amended for clarification. The section presently reads:

70. Where for the purpose of any work or undertaking or for the acquisition of property or for any other object within its powers a local authority desires to raise moneys by way of debentures, the local authority shall apply to the Board for authority to do so.

3. Section 71, subsection (2) is amended for clarification. Section 71 presently reads:

71. (1) In the case of an urban municipality, the application to the Board shall be made before or forthwith after the first reading of a by-law providing for the debenture and before the by-law is submitted to a vote of the proprietary electors of the urban municipality.

(2) No further action shall be taken by the local authority of the urban municipality upon the by-law providing for the debenture until the authorization of the Board has been obtained as provided in this Part.

4. Section 120 provides for orders separating land from an urban municipality. Subsection (2) presenty reads:

(2) The order may be made subject to such terms and conditions as to the Board seem proper, and becomes effective upon the date named in the order or in the absence of any date therein upon the date of the publication of the order in the Gazette.

5. Section 124 deals with orders annexing land to cities. Subsection (3) presently reads:

(3) The order becomes effective upon the date named in the order or in the absence of any date therein upon the date of the publication of the order in the Gazette.

6. Commencement of Act.

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act amends The Local Authorities Board Act.

2. Section 70 is amended by adding at the end thereof the words "before commencing or undertaking the works or project".

3. Section 71 is amended by striking out subsection (2) and by substituting the following:

(2) No further action, including advertising, shall be taken by the urban municipality upon the by-law providing for the debenture until the authorization of the Board has been obtained as provided in this Part.

4. Section 120 is amended by striking out subsection (2) and by substituting the following:

(2) The order may be made subject to such terms and conditions as to the Board seem proper.

(2a) The order shall be published in the *Gazette* and becomes effective upon the date named in the order, or in the absence of any date therein, upon the date of the publication of the order in the *Gazette*.

5. Section 124, subsection (3) is amended by adding before the words "becomes effective" the words "shall be published in the *Gazette* and".

6. This Act comes into force on the day upon which it is assented to.
