BILL 126

A Bill to amend The M. L. A. Compensation Act

HON. MR. REIERSON

Explanatory Note

1. This Bill amends chapter 206 of the Revised Statutes.

2. (a) Section 2, clause (b) presently reads:

(b) "compensation" means

(i) in the case of a member of the Legislative Assembly, the maximum payments payable under section 45 and subsection (3) of section 50 of The Workmen's Compensation Act, to a workman suffering permanent total disability, and

(ii) in the case of a dependant of a member of the Legislative Assembly, compensation equivalent to and payable in the same manner and upon the same basis as the compensation payable under The Workmen's Compensation Act, to a similar dependant of a workman under that Act;

(b) Section 2, clause (e) reads:

(e) "permanent total disability" means personal injury to the extent that the member of the Legislative Assembly would, if he were a workman under The Workmen's Compensation Act, be found to be permanently totally disabled.

3. Section 3 presently reads:

3. Where an accident arising out of and in the course of the performance of any duty of a member of the Legislative Assembly results in the permanent total disability of or death to the member of the Legislative Assembly, compensation shall be paid therefor by the Board

(a) to or on behalf of the disabled member of the Legislative Assembly in the case of his permanent total disability, or

(b) to or on behalf of the dependants of the member in the case of his death.

4. Section 4 presently reads:

4. Compensation shall be paid

(a) in the case of permanent total disability from the date of such disablement, or

(b) in the case of death, from the date of the death.

5. Section 9 reads:

9. No compensation shall be paid under this Act to or in respect of a person while pension payments for his previous service on the Executive Council are being paid under The Public Service Pension Act to or in respect of that person.

6. Commencement of Act.

An Act to amend The M. L. A. Compensation Act

(Assented to _____, 1965)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. *The M.L.A. Compensation Act* is hereby amended.
2. Section 2 is amended
 - (a) as to clause (b) by striking out subclause (i) and by substituting the following:
 - (i) in the case of a member of the Legislative Assembly
 - (A) the maximum payments payable under section 45 and subsection (3) of section 50 of *The Workmen's Compensation Act* to a workman suffering permanent total disability, or
 - (B) the maximum payments payable under section 46 and subsection (3) of section 50 of *The Workmen's Compensation Act* to a workman suffering permanent partial disability,as the circumstances require, and
 - (b) by adding the following clause after clause (e):
 - (f) "permanent partial disability" means personal injury to the extent that the member of the Legislative Assembly would, if he were a workman under *The Workmen's Compensation Act*, be found to be permanently partially disabled.
3. Section 3 is amended by adding after the words "permanent total disability" wherever they occur the words "or permanent partial disability".
4. Section 4, clause (a) is amended by adding after the words "permanent total disability" the words "or permanent partial disability".
5. Section 9 is repealed.
6. This Act comes into force on the day upon which it is assented to.
