## BILL 45

A Bill to amend The Coal Mines Regulation Act

#### **Explanatory Note**

- 1. This Bill amends chapter 47 of the Revised Statutes.
- 2. (a) Section 10, subsection (1) presently reads:
  - 10. (1) The Lieutenant Governor in Council may appoint a Board of Examiners consisting of
    - (a) the Director or an inspector nominated by him,
    - (b) two managers, and
    - (c) two persons, each of whom is a miner or is employed at a strip mine.

The amendment permits the appointment to the Board of persons of the categories described in clauses (b) and (c) whether or not they are presently employed in the operation of a mine.

(b) Self-explanatory.

- 3. Section 16, subsection (4) presently reads:
  - (4) A manager or an assistant manager shall be the holder of a first class certificate as a mine manager for the type of mine, whether strip or underground, for which he is appointed.

An Act to amend The Coal Mines Regulation Act

, 1966)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. The Coal Mines Regulation Act is hereby amended.
- 2. Section 10 is amended
  - (a) by striking out subsection (1) and by substituting the following:
    - 10. (1) The Lieutenant Governor in Council may appoint a Board of Examiners consisting of
    - (a) the Director or an inspector nominated by him,
    - (b) two persons, each of whom
      - (i) is the holder of a first class certificate for underground mining, or
      - (ii) is the holder of a manager's certificate for a strip mine,

and

- (c) two persons, each of whom
  - (i) is the holder of a miner's certificate, or
  - (ii) has five years' strip mining experience.
- (b) by adding the following subsection after subsection (2):
  - (2a) The Director or the inspector nominated by him and at least two other members of the Board may perform any function of the Board and when performing any such function have all the powers and jurisdiction of the Board.
- 3. Section 16 is amended by striking out subsection (4) and by substituting the following:
- (4) No person shall be appointed as or act as a manager or an assistant manager
  - (a) of an underground mine, unless he is the holder of a first class certificate for underground mining, or
  - (b) of a strip mine, unless he is the holder of a manager's certificate for a strip mine.

- 4. See note to clause 5 of this Bill.
- 5. The new section 69a provides for the certification of strip mine surveyors without the requirement of experience in surveying underground mines.

6. Commencement of Act.

- **4.** Section 46, subsection (4) is amended by adding the word "or" at the end of clause (b) and by adding the following clause:
  - (c) hold a strip mine surveyor's certificate.
  - 5. The following section is added after section 69:
- 69a. No person shall hold or be granted a strip mine surveyor's certificate unless
  - (a) he
    - (i) has had two years' practical experience in surveying strip mines, or
    - (ii) has had one year's practical experience in surveying strip mines and two years' practical experience in surveying with an Alberta land surveyor or a Dominion land surveyor, or
    - (iii) has had two years' study in engineering in an educational institution approved by the Board, or
    - (iv) is an Alberta land surveyor or a Dominion land surveyor,

and

- (b) he can
  - (i) make an accurate survey of the workings of a strip mine,
  - (ii) make accurate surveys and levellings, and
  - (iii) plot accurately surveys and levellings.
- 6. This Act comes into force on the day upon which it is assented to.
