Explanatory Note

I. This clause amends chapter 27 of the Revised Statutes. Subsection (1) and clause (k) of subsection (2) of section 4 presently read:

4. (1) This Act applies to all pressure plants and pressure vessels within or subject to the legislative power of the Province except as otherwise provided by subsection (2).

(2) This Act does not apply to

(k) pipe lines within the meaning of The Pipe Line Act, 1958, except pressure vessels, steam or refrigerating or other pressure plants, which form the whole or any part of installations as defined in that Act.

The new subsection (3) will permit the Lieutenant Governor in Council to exempt any class of pressure vessels from the application of the Act.

2. This clause amends chapter 58 of the Statutes of Alberta, 1958. The amendment is made as a consequence of the amendments in clause 1 above. Section 53a presently reads:

53a. The Boilers and Pressure Vessels Act and the regulations thereunder apply to the manufacturing, installation and inspection of any pressure vessel and any steam or refrigerating or other pressure plant, as defined in that Act, which form the whole or any part of an installation to which this Act applies.

H^{ER} MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. Section 4 of *The Boilers and Pressure Vessels Act* is amended

- (a) as to subsection (1) by striking out the words "by subsection (2)" and by substituting the words "by subsections (2) and (3)",
- (b) as to subsection (2)
 - (i) by adding the word "or" at the end of clause
 (i) and by striking out the word "or" at the end of clause (j),
 - (ii) by striking out clause (k),
- (c) by adding the following subsection:

(3) This Act applies to pressure vessels, steam and refrigeration and other pressure plants which form the whole or any part of an installation as defined in *The Pipe Line Act*, 1958 but it does not apply

- (a) to any class of such pressure vessels that is exempted from the application of this Act by order of the Lieutenant Governor in Council, or
- (b) to any other part of a pipe line within the meaning of *The Pipe Line Act*, 1958.

2. Section 53a of *The Pipe Line Act, 1958* is amended by adding after the words "as defined in that Act" the words "and to which that Act applies".

3. This Act comes into force on the day upon which it is assented to.
