A Bill to amend The Cultural Development Act

#### **Explanatory Note**

1. This Bill amends chapter 73 of the Revised Statutes.

2. Section 14, subsections (1), (2) and (4), clause (c) presently read:

14. (1) In this section "council" includes the Minister of Municipal Affairs in respect of an improvement district or special area and the board of administrators of a new town under The New Towns Act.

- (2) A council of a municipality may by by-law
- (a) provide for the establishment of recreation areas in the municipality,
  (b) authorize agreements with other municipalities to provide for joint recreation programs and joint recreation boards to manage such programs, and
- (c) appropriate moneys for the use of joint recreation boards.

(4) Notice of a proposed by-law to be passed pursuant to sub-section (3) shall be advertised

(c) in the case of a county or municipal district, by posting notices in at least fifteen conspicuous places for at least thirty days and by publishing a like notice in one issue of a newspaper having general circulation in the county or municipal district.

### An Act to amend The Cultural Development Act

#### (Assented to , 1966)

**H**<sup>ER</sup> MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The Cultural Development Act is hereby amended.

**2.** Section 14 is amended

- (a) by striking out subsection (1) and by substituting the following:
  - **14.** (1) In this section,
  - (a) "council" includes
    - (i) the Minister of Municipal Affairs in respect of an improvement district or special area,
    - (ii) the board of administrators of a new town under The New Towns Act, and
    - (iii) the board of trustees of a school district situated within a national park;
  - (b) "municipality" includes a school district situated within a national park.
- (b) as to subsection (2) by striking out the word "and" at the end of clause (b), by adding the word "and" at the end of clause (c) and by adding the following clause:
  - (d) expend moneys for capital works related to a recreation program within the municipality or to a joint recreation program.
- (c) as to subsection (4), clause (c) by adding after the words "municipal district" wherever they occur the words "or school district".

**3.** This Act comes into force on the day upon which it is assented to.
