An Act to amend The Department of Youth Act

(Assented to , 1967)

H^{ER} MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The Department of Youth Act is amended by striking out section 6 and by substituting the following:

6. (1) The Minister of Youth may, subject to the regulations, make grants to municipalities, to organizations and to persons or classes of persons for the purpose of carrying into effect any of the matters specified in clauses (b) to (e) of section 4.

(2) The Lieutenant Governor in Council may make regulations

- (a) prescribing the purposes for which grants may be made under this section,
- (b) specifying to whom and upon what conditions the grants may be paid,
- (c) limiting the maximum amount payable as grants, and
- (d) respecting any other matter necessary or advisable to carry out the intent and purpose of this section.

(3) Any grant made under this section shall be paid out of the moneys appropriated by the Legislature for the purpose or, in the absence of any such appropriation, out of the General Revenue Fund.

7. (1) The Minister of Youth may establish advisory committees on youth

- (a) to consider and advise him on such matters relating to young people as is desirable to enable him and his Department to carry out the intent and purpose of this Act, and
- (b) to undertake such other functions and duties as may be given to it by the Minister or the Lieutenant Governor in Council.

(2) The advisory committees on youth shall consist of such number of members as may be appointed thereto by the Minister.

Explanatory Notes

General. This Bill amends chapter 110 of the Statutes of Alberta, 1966.

A new section 6 is added authorizing the payment of grants in aid of various youth activities. New sections 7, 8 and 9 are added authorizing the establishment of advisory committees and councils on matters affecting young people. (3) The Minister may fix the term of office of the persons appointed to a committee and may designate one of the members as chairman.

8. (1) The Minister of Youth may establish councils of young people to advise and inform him and the Government, from the point of view of youth,

- (a) on the attitudes of the young people of Alberta with respect to matters of general public interest or concern, and
- (b) on matters of particular interest or concern to the young people of Alberta.

(2) The councils of young people shall consist of such number of young persons as may be appointed thereto by the Minister as being representative of the youth of the Province.

(3) The Minister may fix the term of office of the persons appointed to a council and may designate one of the members as chairman.

9. (1) The members of the advisory committees on youth and the councils of young people shall receive no remuneration for their services, but the Lieutenant Governor in Council may by regulation authorize the payment of such subsistence allowances, travelling expenses and other expenses as he considers proper and expedient in connection with the attendance of members at meetings of the committee or council or their duties while otherwise engaged in the work of the committee or council, as the case may be.

(2) Payments authorized by this section shall be made out of the moneys appropriated by the Legislature for that purpose.

2. This Act comes into force on the day upon which it is assented to.
