An Act to amend The University and College Assistance Act

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. The University and College Assistance Act is hereby amended.
 - 2. Section 7, subsection (1) is amended
 - (a) as to clause (a) by striking out the words "six hundred and fifty dollars" and by substituting the figures "\$900",
 - (b) as to clause (b) by striking out the words "five hundred and four dollars" and by substituting the figures "\$900".
 - 3. Section 9 is amended
 - (a) by striking out subsection (1),
 - (b) as to subsection (2) by striking out the word "committee" and by substituting the words "Universities Commission".
- 4. Part A of the Schedule is amended as to paragraph (1) by striking out the words "sixteen hundred dollars" and by substituting the figures "\$2,315".
 - 5. Part B of the Schedule is amended as to paragraph (1)
 - (a) by striking out the words "six hundred and seventy-five dollars" in clause (a) and by substituting the figures "\$1,050",
 - (b) by striking out the words "nine hundred dollars" in clause (b) and by substituting the figures "\$1,050".
- **6.** This Act comes into force on the day upon which is assented to.

Explanatory Notes

- 1. This Bill amends chapter 102 of the Statutes of Alberta, 1964.
- 2. Section 7(1) presently reads:

 - 7. (1) Subject to the provision of funds therefor by the Legislature, there shall be paid to each private junior college in each year

 (a) the sum of six hundred and fifty dollars for each student ordinarily resident in Alberta who is enrolled in university courses acceptable to the university with which the college is affillated as constituting a full year's work toward a degree and who is so enrolled on the first day of December in that year or on such other date as may be fixed by the Lieutenant Governor in Council, and
 - (b) the sum of five hundred and four dollars for each student en-rolled in at least four university courses and at least one matri-culation course, on the first day of December or on such other date as may be fixed by the Lieutenant Governor in Council.
- 3. Section 9(1) establishes a review committee for the purposes stated in subsection (2) which presently reads:
 - (2) On or before the fifteenth day of January in each year the committee shall examine and consider the Schedule to this Act and make recommendations respecting the provision of the Schedule to the Government.
 - 4. Paragraph (1) of Part A presently reads:
 - (1) There shall be paid to the Universities Commission a grant in the sum of sixteen hundred dollars for $\,$
 - (a) each undergraduate student who is registered at a university for courses constituting a normal full year's program as defined for fee assessment purposes, and
 - (b) each graduate student who is registered at a university for a program of studies equivalent in courses and research to not less than three full graduate courses,
 - and who was so registered on the first day of December.
 - 5. Paragraph (1) of Part B presently reads:

 - (1) There shall be paid to a public junior college in respect of each student referred to in clause (a) of subsection (1) of section 5
 (a) the sum of six hundred and seventy-five dollars when the major number of the courses being taken by the student are first year courses, and
 - (b) the sum of nine hundred dollars when the major number of courses being taken by the student are beyond first year courses.
