An Act for the Granting to Her Majesty Certain Sums of Money for the Public Service for the Fiscal Years Ending Respectively the 31st Day of March 1967, the 31st Day of March, 1968, and the 31st day of March, 1969

(Assented to _____, 1968)

Most Gracious Sovereign:

WHEREAS it appears by Messages from His Honour, J. W. Grant MacEwan, Lieutenant Governor of the Province of Alberta, and the Estimates accompanying the Messages, that the sums hereinafter mentioned are required to defray certain expenses of the Public Service of Alberta not otherwise provided for during the financial periods ending respectively, the 31st day of March, 1967, the 31st day of March, 1968, and the 31st day of March, 1969, and for other purposes relating thereto:

MAY IT THEREFORE PLEASE YOUR MAJESTY that it be enacted and be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, as follows:

1. This Act may be cited as *The Appropriation Act No. 2, 1968*.

2. From and out of the General Revenue Fund there may be paid and applied a sum not exceeding, in the whole, \$3,446,569.95 towards defraying the several charges and expenses of the Public Service from the 1st day of April, 1966, to the 31st day of March, 1967, not otherwise provided for and set forth in Schedule "A" to this Act.

3. From and out of the General Revenue Fund, there may be paid and applied a sum not exceeding in the whole, \$27,658,998.20, towards defraying the several charges and expenses of the Public Service from the 1st day of April, 1967 to the 31st day of March, 1968 not otherwise provided for and set forth in Schedule "B" to this Act.

4. From and out of the General Revenue Fund, there may be paid and applied a sum not exceeding \$875,674,485 towards defraying the several charges and expenses of the

Public Service from the 1st day of April, 1968, to the 31st day of March, 1969, not otherwise provided for, and set forth in Schedule "C" to this Act less the amounts voted on account for those items in *The Appropriation Act No. 1, 1968*.

5. The due application of all moneys expended under this Act shall be accounted for.

6. This Act comes into force on the day upon which it is assented to.
