An Act to amend The Agricultural and Vocational
Colleges Act

(Assented to _____, 1968)

HER MAJESTY, by and with the advice and consent of
the Legislative Assembly of the Province of Alberta,
enacts as follows:

1. *The Agricultural and Vocational Colleges Act* is hereby amended.

2. Section 3 is struck out and the following section is substituted:

3. The Lieutenant Governor in Council may establish an agricultural and vocational college

- (a) in connection with each of the farms owned by the Province for agricultural teaching purposes, and
- (b) at such other places within the Province as may be determined by the Lieutenant Governor in Council.

3. Section 7, subsection (2) is amended

- (a) by striking out subclause (vi),
- (b) by adding the following clause after clause (a):
 - (a1) one member representing all the agricultural and vocational colleges alumni associations, and

4. Section 16 is amended by striking out the words "a diploma" and by substituting the words "a diploma, certificate or such other formal recognition as the Minister, in his discretion, may approve".

5. This Act comes into force on the day upon which it is assented to.

Explanatory Notes

- 1.** This Bill amends chapter 3 of the Statutes of Alberta, 1967.
- 2.** This re-enactment of section 3 is for clarification. Section 3 presently reads:
 - 3.** The Lieutenant Governor in Council may establish
 - (a) an agricultural and vocational college in connection with each of the farms owned by the Province for agricultural teaching purposes, or
 - (b) at such other places within Alberta as may be determined by the Lieutenant Governor in Council.
- 3.** There are now three agricultural and vocational colleges, each having its own alumni association. The amendment also makes it clear that the several alumni associations are all represented by one and the same person on the Board. Section 7, subsection (2) presently reads:
 - (2) The nine remaining members shall all be appointed by the Lieutenant Governor in Council and shall consist of
 - (a) one representative from the governing body of each of the following organizations:
 - (i) The Alberta School Trustees Association;
 - (ii) The Alberta Association of Municipal Districts;
 - (iii) The Alberta Federation of Agriculture;
 - (iv) The Farm Women's Union of Alberta;
 - (v) Alberta Women's Institute;
 - (vi) Agricultural and Vocational Colleges Alumni Association;
 - and
 - (b) three members appointed at large.
- 4.** This amendment enables the Minister to bestow different classes or forms of recognition for different classes or types of courses. Section 16 presently reads:
 - 16.** Every student who
 - (a) attends satisfactorily any full course of study prescribed by the Board,
 - (b) complies with the requirements of any related prescribed practical course, and
 - (c) passes the required examinations,is entitled to receive a diploma.
