An Act to amend The School Act (No. 2)

(Assented to \_\_\_\_\_, 1968)

**H**ER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. *The School Act* is hereby amended.
2. Section 98 is amended by striking out the words "*The Town and Village Act* or *The City Act*, as the case may be" and by substituting the words "*The Municipal Election Act*".
3. Section 104 is amended by striking out the figure "21" and by substituting the figure "19".
4. Section 105 is amended
  - (a) by striking out the figure "21" and by substituting the figure "19",
  - (b) by striking out the word "six" and by substituting the figure "12".
5. Section 106, clause (a) is amended
  - (a) by striking out the figure "21" and by substituting the figure "19",
  - (b) by striking out the words "*The Town and Village Act* or of *The City Act*" and by substituting the words "*The Municipal Election Act*".
6. Section 109, subsection (2) is amended by striking out the words "section 175 of *The City Act*" and by substituting the words "*The Municipal Election Act*".
7. Section 110, subsection (2) is amended by striking out the words "*The Town and Village Act*, or in the case of a city district, the provisions of *The City Act*," and by substituting the words "*The Municipal Election Act*".
8. Section 147, subsections (1) and (3) are amended by striking out the words "*The Controverted Municipal*

## **Explanatory Notes**

**I. General.** This Bill amends chapter 297 of the Revised Statutes. The amendments are consequential on the enactment of The Municipal Election Act, The Municipal Government Act and The Municipal Taxation Act.

**11.** Section 284, subsection (1) is amended by striking out the words "subsection (4a) of section 331 of *The Municipal District Act*, subsection (4a) of section 8 of *The Improvement Districts Act*" and by substituting the words "subsection (2) of section 86 of *The Municipal Taxation Act*".

**12.** Section 297, subsection (1) is amended by striking out the words "subsection (4a) of section 331 of *The Municipal District Act*, subsection (4a) of section 8 of *The Improvement Districts Act*" and by substituting the words "subsection (2) of section 86 of *The Municipal Taxation Act*".

**13.** Section 306, subsection (4) is amended by striking out the words "*The Town and Village Act*," and by substituting the words "*The Municipal Government Act*".

**14.** Section 306a, subsection (1) is amended by striking out the words "*The Town and Village Act*," and by substituting the words "*The Municipal Government Act*".

**15.** Section 453, subsection (1) is amended by striking out the words "*The City Act or The Town and Village Act*," and by substituting the words "*The Municipal Government Act and The Municipal Election Act*".

**16.** This Act comes into force on June 1, 1968.
