An Act to amend The Chiropractic Profession Act

(Assented to

, 1970)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. The Chiropractic Profession Act is hereby amended.
- 2. Section 6 is amended by adding the following clause after clause (g):
 - (g1) the amounts payable to the Association as registration fees, annual fees or for any service provided by an officer of the Association;
 - 3. Section 11, subsection (1), clause (b) is amended
 - (a) as to subclause (i) by striking out the word "or" and by substituting the word "and",
 - (b) as to subclause (ii) by striking out the words "a written" and by substituting the word "an".
- 4. Section 12, subsection (1) is amended by striking out clause (d) and by substituting the following clause:
 - (d) either
 - (i) has received the degree of doctor of chiropractic from a college listed by the Board and has passed such examinations as may be prescribed by the Board, or
 - (ii) is a member in good standing of the Canadian Chiropractic Association and has fulfilled all the requirements under the regulations of the Canadian Chiropractic Association pertaining to reciprocity,
 - 5. Section 15 is amended by striking out subsection (2).
 - 6. This Act comes into force on July 1, 1970.

Explanatory Notes

- 1. This Bill amends chapter 14 of the Statutes of Alberta, 1966.
- 2. Section 6 commences:

6. Subject to the approval of the Lieutenant Governor in Council, the council may make by-laws governing:

- 3. Section 11, subsection (1), clause (b) presently reads:
 - 11. (1) The Board shall establish
 - (b) a registry recording the name of each person

 - (i) who by submitting credentials has satisfied the Board that he is a graduate of a college listed by the Board, or
 (ii) who has passed a written examination in chiropractice prescribed by the Board.

See note to clause 4 of this Bill.

- **4.** Section 12, subsection (1), clause (d) presently reads:
 - 12. (1) The council shall register as a member of the Association ${\bf a}$ person who
 - (d) has received the degree of doctor of chiropractic from a college listed by the Board or has passed such examinations as may be prescribed by the Board, or is a member in good standing of the Canadian Chiropractic Association and has fulfilled all the regulations of the Canadian Chiropractic Association pertaining to reciprocity,

The present clause (d) sets out three ways of qualifying for registration, and the effect of the amendment is to reduce these to two. Where an applicant can presently qualify by showing that he is a graduate of an approved college or by passing examinations set by the Chiropractic Appraisal Board of Alberta, the applicant will now have to do both.

- 5. Section 15, subsection (2) presently reads:
 - (2) The annual fee payable under this Act to the Association by an active member shall not exceed the sum of two hundred dollars.

The annual fee will be fixed by the by-laws. See clause 2 of this Bill.
