# BILL 29

An Act to amend The Colleges Act

(Assented to \_\_\_\_\_, 1970)

**H**ER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. *The Colleges Act* is hereby amended.

2. Section 5 is amended by striking out subsection (2) and by substituting the following subsection:

(2) The members, other than the chairman, shall not receive any remuneration for their services except that the Commission

(a) shall pay to all members their reasonable travelling and living expenses while absent from their ordinary places of residence and in the course of their duties as members, and

(b) may pay to any member, other than the chairman, compensation for any loss or expense incurred by a member and which, in the opinion of the Commission, was necessary and directly incurred by the member as a result of being absent from his ordinary place of residence in the course of his duties as a member.

3. Section 20, subsection (3) is amended by striking out the words "the Minister of Education or the Minister of Agriculture, as the case may be" and by substituting the words "the Minister of the department of which the provincially-owned institution is a part".

4. Section 32, subsection (4) is amended by adding after clause (a) the following clause:

(a1) the member nominated by the academic staff association of the college, or

## **Explanatory Notes**

**1.** This Bill amends chapter 14 of the Statutes of Alberta, 1969.

**2.** Section 5, subsection (2) presently reads:

(2) The members, other than the chairman, shall not receive any remuneration for their services, but the Commission shall pay to all members their reasonable travelling and living expenses while absent from their ordinary places of residence and in the course of their duties as members of the Commission.

**3.** Section 20, subsection (3) presently reads:

(3) An order under subsection (1) shall specify either that the Minister of Education or the Minister of Agriculture, as the case may be, or a named officer of his department is to act as the college board for the purposes of this Act and in construing those provisions of this Act that apply to the institution, a reference to a college board shall be read as a reference to that Minister or that officer, as the case may be.

Section 20, subsection (1) provides for an Order in Council declaring a provincially-owned institution to be a member of the college system.

**4.** Section 32, subsection (4) commences:

(4) Notwithstanding subsection (2), the Lieutenant Governor in Council may prescribe the term of office of a member as a period of less than three years in the case of

**5.** Section 36 is amended by adding the following clause after clause (f) :

(f1) borrow money from any person or enter into overdraft arrangements with a chartered bank or treasury branch and give security for the repayment of such moneys;

**6.** Section 41 is amended by adding after the words “signed by the treasurer” the words “or an employee of the college board authorized by the board for that purpose”.

**7.** Section 45, subsection (2), is amended by striking out the words “, subject to the approval of the Commission, prescribe”.

**8.** This Act comes into force on the day upon which it is assented to.

**5.** Section 36 enumerates the powers of public college boards.

**6.** Section 41 presently reads:

41. The college board shall require that all of its funds be kept in a chartered bank or treasury branch and be paid by cheques or orders signed by the treasurer and by either the chairman of the board or such other member as may be designated by the board.

**7.** Section 45, subsection (2) presently reads:

(2) The college board shall appoint the president and prescribe his tenure of office and, subject to the approval of the Commission, prescribe the remuneration to be paid to him by the board.
