THE ELECTION STATUTES AMENDMENT ACT, 1972

(Assented to _____, 1972)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

1. *The Election Act is amended by striking out the words "Clerk of the Executive Council" where they occur in the provisions listed in the Schedule to this Act and by substituting the words "Clerk of the Legislative Assembly".*

2. *The Controverted Elections Act is amended as to section 21, subsections (2), (3) and (4), section 24, subsection (1) and section 30, subsection (1) by striking out the words "Clerk of the Executive Council" and by substituting the words "Clerk of the Legislative Assembly".*

3. *The Electoral Boundaries Commission Act is amended as to section 3, clause (e) by striking out the words "Clerk of the Executive Council" and by substituting the words "Clerk of the Legislative Assembly".*

4. *The Legislative Assembly Act is amended as to section 26 and section 27, subsections (1) and (2) by striking out the words "Clerk of the Executive Council" and by substituting the words "Clerk of the Legislative Assembly".*

5. *The Liquor Plebiscites Act is amended as to section 2, clause (a) by striking out the words "Clerk of the Executive Council" and by substituting the words "Clerk of the Legislative Assembly".*

6. *This Act comes into force on the day upon which it is assented to .*

Explanatory Notes

1. This section will amend chapter 117 of the Revised Statutes of Alberta 1970. The duties of the Clerk of the Executive Council in respect of election proceedings are transferred to the Clerk of the Legislative Assembly.

2. This section will amend chapter 66 of the Revised Statutes of Alberta 1970. See note to clause 1 of this Bill.

3. This section will amend chapter 118 of the Revised Statutes of Alberta 1970. See note to clause 1 of this Bill.

4. This section will amend chapter 204 of the Revised Statutes of Alberta 1970. See note to clause 1 of this Bill.
