AN ACT TO AMEND THE CANADIAN UNION COLLEGE ACT

(Assented to , 1973)

Preamble

WHEREAS Canadian Union College, formerly known as Canadian Junior College, has presented a petition praying for the amendment of *The Canadian Union College Act*, being chapter 35 of the Statutes of Alberta, 1940, as amended; and

WHEREAS it is expedient to grant the prayer of the said petition;

NOW THEREFORE Her Majesty, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

1940, c. 35

1. The Canadian Union College Act is hereby amended.

Amends s. 1

2. Section 1 is amended by striking out subsection (2) and by substituting the following subsection:

(2) The Canadian Union College shall have power to establish, maintain and conduct at College Heights, or elsewhere in the Province of Alberta, a college for the education of youth and the promotion of knowledge on the elementary, secondary and post-secondary levels of instruction where students may obtain a liberal education in the arts and sciences and to promote the study, practice and knowledge thereof including vocational training and in connection with such training to carry on any vocation and to provide for the delivery and holding of lectures, exhibitions, classes, experiments, laboratories and conferences calculated directly or indirectly to advance the cause of education, whether general, professional or technical, to award certificates and diplomas, confer academic degrees, subject to the provisions of The Universities Act, for merit and proficiency and to appoint such professors, associate professors, lecturers, instructors or other officers and servants and such other powers as may be necessary for carrying into effect the objects and purposes of Canadian Union College.

Commencement 3. This Act comes into force on the day upon which it is assented to.

Explanatory Notes

1. This Bill will amend Chapter 35 of the Statutes of Alberta, 1940.
