THE LEGISLATIVE ASSEMBLY AMENDMENT ACT, 1974 (NO. 2)

(Assented to _____, 1974)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

1. *The Legislative Assembly Act is hereby amended.*

2. *Section 12 is amended*

(a) *as to clause 1 by adding after the word "shareholder" the word ", member",*

(b) *as to clause 3 by adding after the words "The Public Service Pension Act" the words ", The Public Service Management Pension Act",*

(c) *by adding the following clause after clause 29:*

29.1 being a member of a co-operative association, or being a member, shareholder or director of a corporation that is a member of a co-operative association, where the co-operative association enters into a contract or agreement with Her Majesty under which public moneys are given to or loaned to the association or where any guarantee is given by or on behalf of Her Majesty for the repayment of any indebtedness of the co-operative association, or

(d) *as to clause 16 by striking out subclause (iii) and by substituting the following:*

(iii) any tax refund, tax reduction or grant under Part 1 of *The Alberta Property Tax Reduction Act*, or

(iv) a renter assistance credit under *The Alberta Income Tax Act*,

or

3. *This Act comes into force on the day upon which it is assented to.*

Explanatory Notes

1. This Bill will amend chapter 204 of the Revised Statutes of Alberta 1970.

2. Section 12, clauses 1, 3 and 16 presently read:

12. Nothing in this Act renders any person ineligible to be nominated for or elected as a member of the Legislative Assembly or disqualifies him from sitting or voting in the Legislative Assembly, by reason only of the person

1. being a shareholder or director of a corporation having a contract or agreement with the Crown in right of the Province, other than a corporation that undertakes a contract for the building of a public work, within the meaning of The Public Works Act, for the Province, or
3. receiving or having received or agreed to receive compensation under The M.L.A. Compensation Act or any pension under The Public Service Pension Act or The M.L.A. Pension Act, or
16. applying for or receiving
 - (i) a discount in respect of municipal taxes or a mobile unit licence fee pursuant to The Homeowners Tax Discount Act, or
 - (ii) a home owner assistance grant or renter assistance grant under The Senior Citizens Shelter Assistance Act, or
 - (iii) a homeowner refund or renter assistance grant under Part 1 of The Alberta Property Tax Reduction Act, or
