Preamble

WHEREAS the persons hereinafter named have by their petition prayed that it be enacted as hereinafter set forth and it is expedient to grant the prayer of the petition:

THEREFORE Her Majesty, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

Short title

1. This Act may be cited as The Alberta Motor Association Insurance Company Act.

Incorporation 2. Bernie Brown, Retired Businessman; Bruno Dale, Executive; Douglas D. Hollands, Chartered Accountant; George A. MacDonald, Executive; and Kenneth W. Quinn, Businessman; all of the City of Edmonton, in the Province of Alberta, and Glenn E. Lockwood, Retired, of the City of Calgary, in the Province of Alberta, and Stanley C. James, Optometrist, of the City of Medicine Hat, in the Province of Alberta, together with such persons as become shareholders in the Company, are incorporated under the name of ALBERTA MOTOR ASSOCIATION INSURANCE COMPANY, hereinafter called "the Company".

Directors

3. The persons named in section 2 shall be the provisional directors of the Company.

Capital stock

4. (1) The capital stock of the Company shall be 1,200,-000 which may be increased to 4,000,000.

(2) The capital stock of the Company shall be divided into shares of a par value of \$100 each.

Subscription

5. (1) The amount to be subscribed before the general meeting for the election of directors is called shall be \$100,000.

(2) Unless the Company applies for a licence under *The Alberta Insurance Act* within two years after the commencement of this Act or within such extended period not exceeding one year as the Lieutenant Governor in Council allows,

- (a) the Company shall not be licensed under The Alberta Insurance Act, and
- (b) the incorporation of the Company ceases to be in force except for the purpose of winding up the affairs of the Company and returning to the subscribers the amounts paid by them upon the subscribed stock or so much thereof as they may be entitled to.

- Head office **7.** The head office of the Company shall be in the City of Edmonton, in the Province of Alberta.
- Class of business **8.** The Company is hereby empowered to carry on and engage in the business of entering into contracts of insurance of all classes and kinds, except life insurance, and against contingencies of all descriptions or by way of guarantee or surety and may reinsure and do all acts and things which are requisite for the purpose of engaging in or carrying on the business of insurance in such kinds and classes.

Commence ment of business **6.** The Company shall not commence business until the amount of capital stock required by section 34 of *The Alberta Insurance Act* has been subscribed and paid.
