### **THE APPROPRIATION (INTERIM SUPPLY) ACT, 1975**

(Assented to \_\_\_\_\_, 1975)

MOST GRACIOUS SOVEREIGN:

WHEREAS it appears by Messages from His Honour, Ralph G. Steinhauer, Lieutenant Governor of the Province of Alberta, and the Estimates accompanying the Messages, that the sums hereinafter mentioned are required to defray certain expenditures of the Public Service of Alberta not otherwise provided for during the fiscal year ending March 31, 1976, and for other purposes relating thereto:

MAY IT THEREFORE PLEASE YOUR MAJESTY that it be enacted and be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Alberta, as follows:

**1.** From and out of the General Revenue Fund, there may be paid and applied a sum not exceeding \$1,574,395,432 towards defraying the several charges and expenses of the Public Service from April 1, 1975 to March 31, 1976, not otherwise provided for and being the aggregate of

- (a) one-half of the amount of the items set forth in the Estimates for the fiscal year ending March 31, 1976, as laid before the Legislative Assembly at the present session of the Legislature, except those items set forth in Schedule "A" to this Act, and
- (b) the entire amount of those items set forth in Schedule "A" to this Act, all as set forth in the Estimates for the fiscal year ending March 31, 1976, as laid before the Legislative Assembly at the present session of the Legislature,

less the amounts provided on account for those items in Special Warrants Nos. 136/74-75, 1/75-76, 2/75-76, 3/75-76 and 4/75-76, all as set forth in Schedule "B" to this Act.

## **Explanatory Notes**

**1. Interim appropriation.**

**2.** From and out of the General Revenue Fund, there may be paid and applied a sum not exceeding \$50,000,000 towards defraying the further expenditures of the Public Service from April 1, 1975 to March 31, 1976 as laid before the Legislative Assembly at the present session of the Legislature, less the amount provided on account for this item in Special Warrant No. 140/74-75 authorized by Order in Council numbered O.C. 532/75.

**3.** The due application of all moneys expended under this Act shall be accounted for.

**4.** This Act comes into force on the day upon which it is assented to.
