AN ACT RESPECTING ALBERTA CHILDREN'S HOSPITAL FOUNDATION

(Assented to , 1975)

Preamble

WHEREAS Alberta Children's Hospital Foundation is a society incorporated under the laws of the Province of Alberta and which was formerly known as the Alberta Children's Hospital and the Alberta Crippled Children's Hospital and several other names; and

WHEREAS the hospital formerly owned and operated by the said society has been transferred to the Province of Alberta and its operations are now conducted by the Alberta Children's Provincial General Hospital as authorized by *The Provincial General Hospital Act (1959)* and *The Provincial General Hospitals Amendment Act,* 1972; and

WHEREAS the objects of the society now are:

- (a) To assist the Alberta Children's Provincial General Hospital in providing special services, facilities, research, training of personnel and in paying for such other costs as may benefit the care and health of children, and
- (b) To undertake or assist in such projects as may provide health care facilities and health care services for children, and
- (c) To provide for the administration expenses of the society, and
- (d) To accept donations, gifts, grants, legacies, devises or bequests of real or personal property of every nature and wheresoever situate, for the objects of the society, and

WHEREAS certain unknown persons may have left donations for the benefit of the said hospital under any of its previous names, and

WHEREAS the said society has by its Petition prayed for the passing of an Act ratifying, confirming and declaring that such donations are payable to Alberta Children's Hospital Foundation as hereinafter set forth; and

WHEREAS it is expedient to grant the prayer of the said Petition:

THEREFORE, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

Short title

1. This Act may be cited as, "Alberta Children's Hospital Foundation Donation Act".

Definitions

2. In this Act,

- (a) "court" means any court authorized to adjudicate in the Province in civil matters in which a donation is in question;
- (b) "donation" means any gift, grant, legacy, devise or bequest of real or personal property of every nature and wheresoever situate;
- (c) "society" means the Alberta Children's Hospital Foundation.

Donations to belong to society

3. Any donation which, by its terms, is to be given, conveyed, transferred, demised or otherwise disposed of to any of the following:

- (a) Alberta Red Cross Crippled Children's Hospital;
- (b) Junior Red Cross Hospital;
- (c) Crippled Children's Hospital, Calgary;
- (d) Alberta Red Cross Hospital;
- (e) Alberta Crippled Children's Hospital;
- (f) Alberta Children's Hospital;
- (g) A hospital with a name resembling the foregoing and duly confirmed under section 4 hereof;

is hereby declared to be altered and amended in so far as may be necessary, so that such donation shall be used for the objects of Alberta Children's Hospital Foundation as fully and effectively as though the name "Alberta Children's Hospital Foundation" was included in the terms of the donation in the place and stead of such other name.

Court application

4. Upon the ex parte application of the society to the court requesting an order that the hospital or society referred to in a donation is the Alberta Children's Hospital Foundation, the court may make an order confirming the recipient of the donation as the Alberta Children's Hospital Foundation.

Use of donations **5**. Donations coming within this Act shall be used by the society in accordance with the objects of the society.

Repeal

6. The Alberta Crippled Children's Hospital Donation Act, being chapter 95 of the Statutes of Alberta 1958, is hereby repealed.

Coming into 7. This Act comes into force on the day upon which it is assented to.
