THE STATUTES REPEAL ACT, 1976

(Assented to _____, 1976)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

- 1. The enactments enumerated in the Schedule to this Act are hereby repealed.*
- 2. This Act comes into force on the day upon which it is assented to.*
