THE DEPARTMENT OF ADVANCED EDUCATION AND MANPOWER AMENDMENT ACT, 1976

(Assented to

, 1976)

H^{ER} MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

1. The Department of Advanced Education and Man, power Act is hereby amended.

2. Section 1 is amended by adding the following clause after clause (b):

(b1) "provincially administered institution" means an advanced education institution owned by the Government and operated as part of the Department;

3. The following section is added after section 3:

3.1 (1) Where the Minister is given any power or duy under this Act or the regulations, he may authorize one or more officers or employees in the Department to exercise or perform that power or duty upon such conditions or in such circumstances as the Minister prescribes and thereupon that power or duty may be exercised or performed by the officer or employee so authorized in addition to the Minister.

(2) Subsection (1) does not apply to the power of the Minister to make regulations under this Act.

4. Section 5 is amended

(a) as to clause (b) by striking out the words "vocational, technical or agricultural schools or institutions, or agricultural and vocational colleges" and substituting the words "provincially administered institutions",

(b) by striking out clauses (c), (d) and (f).

5. Section 10 is amended by striking out the words "in Alberta" and substituting the words "inside or outside Alberta".

6. This Act comes into force on the day upon which \sharp is assented to.

Explanatory Notes

This Bill will amend chapter 28 of the Statutes of Alberta,

New definition.

Minister empowered to delegate.

Section 5, clauses (b), (c), (d) and (f) presently read:

5. The Minister may make regulations

- (b) for the establishment, operation, administration and management of vocational, technical or agricultural schools or institutes, or agricultural and vocational colleges;
- (c) concerning the teaching of practical and scientific farming, household economy, domestic and any other matters related to agricultural and vocational colleges;
- (d) for the registration of students in programs offered by the institutions referred to in clause (b);
- (f) providing for correspondence courses and the fees to be charged in connection therewith;

Section 10 presently reads:
