HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

- 1. The Age of Majority Act is amended as to section 15 by striking out the words "The Change of Name Act" wherever they occur and substituting the words "The Change of Name Act, 1973".
- 2. The Alberta Heritage Savings Trust Fund Act is amended as to section 6, subsection (5), clause (c) by striking out the words "subsection (3), clause (b)" and substituting the words "subsection (3), clause (c)".
- 3. The Alberta Historical Resources Act is amended by striking out the word "heritage" wherever it occurs in the following provisions and substituting the word "historic":

section 18, subsection (8);

section 20, subsection (2);

section 20, subsection (3), clause (c).

- 4. The Alberta-Saskatchewan Boundary Act is amended as to section 2 by striking out the words "of the Province of Alberta".

- 15. The Limitation of Actions Act is amended as to section 46, subsection (2) by striking out the words "No such person" and substituting the words "Any such person".
- 16. The Liquor Control Act is amended as to section 100, subsection (2), clause (a) by striking out the words "section 222 or section 224" and substituting the words "section 234 or section 236".
- 17. The Manpower Development Act is amended
 - (a) as to section 12, subsection (3) by striking out the words "section 13,";
 - (b) as to section 29, subsection (1), clause (a) by striking out the word "prerequisite" and substituting the words "educational improvement";
 - (c) as to section 37, subsection (1), clause (e) by striking out the word "Proficiency" and substituting the word "Qualification".
- 18. The Medical Profession Act, 1975 is amended as to section 71, subsection (1) by striking out the words "Minister

12. Section 11(1) presently reads:

11. - 13. Section 3 of The Intestate Succession Act was amended in 1975 to provide for an increased minimum payment of up to \$40,000 to the widow, effective January 1, 1976. Section 3, subsection (3) should also have been amended at that time to reflect the change. This amendment will be retroactive to January 1, 1976.
- 14. Corrects a typographical error.
- 15. Corrects an error that appeared when an earlier section was divided into two subsections in the preparation of the Revised Statutes of Alberta, 1955. The error was carried over into the Revised Statutes of Alberta 1970.
- **16.** This amendment is necessary because of a change in the numbering of the Criminal Code.
- 17. The first amendment corrects an incorrect reference. The second amendment is to make the wording of section 29 consistent with the wording of section 30, subsection (2), clauses (d) and (k). The third amendment corrects an incorrect reference to a Certificate of Proficiency.
