THE METRIC CONVERSION STATUTES AMENDMENT ACT, 1977

(Assented to , 1977)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

1 The Acts enumerated in the Schedules are amended in accordance with the Schedules.

2(1) This Act, except the Schedules, comes into force on the day upon which it is assented to.

(2) The Schedules come into force on a date or dates to be fixed by Proclamation.

SCHEDULE A

SPEED AND DISTANCE

1 The Boilers and Pressure Vessels Act, 1975 (S.A. 1975(2), c.4) is amended

(a) in section 2(2)(d) by striking out "six inches" and substituting "152 millimetres",

(b) in section 2(2)(e) by striking out "24 inches" and substituting "610 millimetres", and

(c) in section 2(2)(h) by striking out "24 inches" and substituting "610 millimetres".

2 The Coal Conservation Act (S.A. 1973, c.65) is amended in section 10(1)(a) by striking out "500 feet" and substituting "150 metres".

3 The Jury Act (R.S.A. 1970, c.194) is amended in section 23(1) by striking out "three inches in length by one and one-half inches in width" and substituting "7.6 centimetres in length by 3.8 centimetres in width".

4 The Land Surface Conservation and Reclamation Act (S.A. 1973, c.34) is amended in section 1(f) by striking out "20 feet" and substituting "6 metres".

5 The Margarine Act (R.S.A. 1970, c.224) is amended in section 6(2) by striking out "one and one-half inches" and substituting "4 centimetres".

6 The Oil and Gas Conservation Act (R.S.A.1970, c.267) is amended

(a) in section 2(1)42 by striking out "500 feet" and substituting "150 metres", and

(b) in section 2(1)46(iv) by striking out "500 feet" and substituting "150 metres".

7 The Public Highways Development Act (R.S.A. 1970, c.295) is amended by repealing section 16(c) and substituting the following:

(c) a statement showing the road length in the system, the distance completely constructed and the stage of construction of distance that is not yet completely constructed.

9 The Road Building Machinery Equipment Act (R.S.A. 1970, c.323) is amended in section 2(2) by striking out "200 miles" and substituting "320 kilometres".

10 The Surveys Act (R.S.A. 1970, c.358) is amended in section 72(1) by adding "or the International System," after "the Canadian".

11 The Threshers' Lien Act (R.S.A. 1970, c.363) is amended in section 4(2) by striking out "five miles" and substituting "8 kilometres".

12 The Water, Gas, Electric and Telephone Companies Act (R.S.A. 1970, c. 387) is amended in section 10 by striking out "six feet" wherever it occurs and substituting "2 metres".

(b) in section 12(b)(i) by striking out "one hundred billion cubic feet of gas or more than one million barrels" and substituting "3 billion cubic metres of gas or 160 thousand cubic metres".

6 The Liquor Control Act (R.S.A. 1970, c.211) is amended

(a) in section 2(2) by striking out "2 1/2 per cent of proof spirits" and substituting "1.43% alcohol by volume",

(i) not less than 255 grams and not more than 261 grams, or

(ii) not less than 510 grams and not more than 518 grams, or

(iv) not less than 1020 grams and not more than 1033 grams,

or

(c) in the case of fruit bread or nut bread, in loaves which shall weigh not less than 450 grams nor more than 458 grams each.

7 The Horned Cattle Purchases Act (R.S.A. 1970, c.173) is amended in section 2(a) by striking out "250 pounds" and substituting "110 kilograms".

8 The Mines and Minerals Act (R.S.A. 1970, c.238) is amended

(a) in section 70 by striking out "\$3.75 a ton" and substituting "\$4.13 per tonne",

(b) in section 78(1) by striking out "10 cents a ton" and substituting "11 cents per tonne",

(c) in section 78(2) by striking out "five cents a ton" and substituting "5.5 cents per tonne", and

(d) in section 79(a) by striking out "seven cents a ton" and substituting "7.7 cents per tonne".

4. "boiler rating" means the rating for measuring the capacity of a boiler in kilowatts as determined in the regulations;

(b) in section 2(2) by repealing clause (a) and substituting the following:

(a) a boiler having a boiler rating of 10 kilowatts or less in capacity which forms the whole or part of a power plant;

(c) in section 2(2) by repealing clause (b) and substituting the following:

(b) a boiler having a boiler rating of 20 kilowatts or less in capacity, installed in a heating plant;

(d) in section 27(4)(c) by striking out "25 boiler horsepower" and substituting "245 kilowatts".

2 The Farm Implement Act (R.S.A. 1970, c.136) is amended in sections 4(1.1) and 14.1 by striking out "horsepower" wherever it occurs and substituting "power".
