THE BURNS MEMORIAL TRUST AMENDMENT ACT, 1981

(Assented to , 1981)

WHEREAS *The Burns Memorial Trust Act* provides that Royal Trust Company is authorized and directed to distribute annually any moneys received by it as Trustee of the Burns Memorial Trust after certain deductions, equally among:

Les Soeurs de Charite de la Providence des Territoires du Nord Ouest;

The Governing Council of the Salvation Army, Canada West;

The Trustees for the Poor, Indigent and Neglected Children of the City of Calgary;

The Trustees for the Widows and Orphans of Members of the Police Force of the City of Calgary;

The Trustees for the Widows and Orphans of Members of the Fire Brigade of the City of Calgary; and

WHEREAS the name of Les Soeurs de Charite de la Providence des Territoires du Nord Ouest has been changed to "The Sisters of Charity of Providence of Calgary"; and

WHEREAS all the petitioners are of the opinion that section 2 of the Act is not consistent with the will of the late Honourable Patrick Burns and have presented a petition praying that the Act be amended, and it is expedient to grant the prayers of the petitioner;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

1 The Burns Memorial Trust Act is amended by this Act.

2 Section 2 is repealed and the following is substituted:

Preamble

- 1 This Bill will amend chapter 64 of the Statutes of Alberta, 1956.
- **2** Section 2 presently reads:

2 Royal Trust Company is hereby authorized and directed to distribute annually the annual income of the Burns Memorial Trust after deducting its reasonable fees and expenses, equally among the following charitable organizations:

(a) The Sisters of Charity of Providence of Calgary;

(b) The Governing Council of the Salvation Army, Canada West;

(c) The Trustees for the Poor, Indigent and Neglected Children of the City of Calgary;

(d) The Trustees for the Widows and Orphans of Members of the Police Force of the City of Calgary;

(e) The Trustees for the Widows and Orphans of Members of the Fire Brigade of the City of Calgary.

3 This Act comes into force on the day upon which it is assented to.

2 Royal Trust Company is hereby authorized and directed to distribute annually any moneys received by it as Trustee of the Burns Memorial Trust from and after the 15th day of March, A.D. 1955, after deducting therefrom its reasonable fees and expenses, equally among the following charitable organizations:

(a) Les Soeurs de Charite de la Providence des Territoires du Nord Ouest;

(b) The Governing Council of the Salvation Army, Canada West;

(c) The Trustees for the Poor, Indigent and Neglected Children of the City of Calgary;

(d) The Trustees for the Widows and Orphans of Members of the Police Force of the City of Calgary;

(e) The Trustees for the Widows and Orphans of Members of the Fire Brigade of the City of Calgary.
