### **HOLY CROSS HOSPITAL (GREY NUNS) OF CALGARY AMENDMENT ACT, 1982**

*(Assented to , 1982)*

WHEREAS a petition has been presented praying that an *Act to Incorporate The Holy Cross Hospital (Grey Nuns) of Calgary*, being chapter 101 of the Statutes of Alberta, 1959, be amended as herein-after set forth and it is expedient to grant the prayer of the petitioner;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

*1 The Holy Cross Hospital (Grey Nuns) of Calgary Act is amended by this Act.*

*2 The title of the Act is struck out the the following is substituted:*

#### **SISTERS OF CHARITY (GREY NUNS) OF CALGARY ACT**

*3 Section 1 is amended by striking out "Holy Cross Hospital (Grey Nuns) of Calgary" and substituting "Sisters of Charity (Grey Nuns) of Calgary".*

*4 Section 15 is amended by striking out "The Holy Cross Hospital (Grey Nuns) of Calgary Act" and substituting "Sisters of Charity (Grey Nuns) of Calgary Act".*

## Explanatory Notes

**1** The Bill will amend chapter 101 of the Statutes of Alberta, 1959.

**2** Amends title.

**3** Section 1 presently reads:

*1. Sr. Claire Gauthier, s.g.m., Superior, Sr. Fernande Champagne, s.g.m., Sr. Louisa Dupuis, s.g.m., Sr. Virginia Rheaume and such other persons as are now or may hereafter become, under the provisions of this Act, members of the said corporation, shall be and are hereby declared to be a body politic and corporate in deed and in name by the name of 'Holy Cross Hospital (Grey Nuns) of Calgary' for the purposes and objects hereinafter set out.*

**4** Section 15 presently reads:

*15. This Act may be cited as 'The Holy Cross Hospital (Grey Nuns) of Calgary Act'.*
