BILL

No. 58 of 1910 (Second Session),

An Act to Incorporate the Calgary Golf and Country Club.

(Assented to 1910.)

WHEREAS, the persons hereinafter named and others are associated together as a club under the name of the Calgary Golf and Country Club to promote the physically elimination of the members and encourage the games of golf, terms, howing together or any other form of series and for social purposest; and

Whereas the said persons bereinafter named have prayed to be incorporated by the name of the Calgary Golf and Coun-

try Club and it is expedient to grant their prayer;

Therefore His Majesty, by and with the advice and reasent of the Legislative Assembly of the Province of Alberta; exacts as follows:

- 1. David J. Young, Frank Macbeth, James H. Woods, David Moffat, Charles, W. Hague, Alban, M. McMahon, Edga, H. Teller, and such other persons as are now or shall bereafter become members of the corporation to be hereby incorporated shall be and are hereby constituted a body politic and corporate by and under the name of the Calgary Golf and Country Club, and by that name shall have perpetual succession and a common seal and shall have power from time to time and anorat all times hereafter, to purely so, acquire, hold, possess, lease and injoy for them and their successors all lands, tenements, i creditargents and real and movemble property and estate situate whether within or without the limits of the City of Calgary, and the same to sell, alienate, exchange, lease and otherwise dispese of or encumber whensoever the said corporation shall deem it proper so to do and by the same name shall and may be enabled to sue and to be sued, to plead and to be impleaded, to answer and to be answered unto in any matter of cause whatsoever; provided always that the actual value of such real estate so held as afon-and shall not at any one time exceed the sum of \$150,000
- 2. The members of the corporation shall have the cole power to frame a constitution and to make by-laws, rules and regulations for the management of the affairs of the corporation, including the regulating of the all-atment and price of stock, making calls thereon, the payment thereof, and the issue and registration of certificates of stock and forfeiture of stock for nonpayment, the disposal of forfeites stock and of the proceeds then of and the transfer of stock, the declaration and payment of dividends, regulating the issue of the club shares of stock and fixing the qualifications of persons who shall be competent to hold the same, the manner in which the same shall be acid and formalities requisite to a valid transfer thereof and the persons to whom they may be transferred.

The constitution, rules, by-laws and regulations of the corporation shall be formulated at a general meeting thereof called for that purpose and of which at least ten days' notice shall be given by public advertisement or otherwise to all the parties thereof, and the constitution, rules, by-laws and regulations, then adopted shall have full force and effect in so far as the same shall not be inconsistent with the laws in force in the Province of Alberta and the provisions of this Act:

Provided always that the said corporation may from time to time after, repeal and change such constitution, rules and regulations in the manner laprein provides by:

- acquire the assets, rights and franchises of the Calgary [Golf Club at present existing or any other club hereafter to be incorporated having objects altogether or in part similar to those of this corporation, and to issue fully or partly paid up shares to the members of such other club for such assets, rights and franchises and on such terms and conditions as may be agreed upon.
- 4. The said corporation shall have a capital of 850,000 divided into 1,000 shates of 850 each, and only those holding at least one share in the said corporation shall be a moral or of the said corporation in full standing. Such shares shall and are hereby vested in the several persons to whom they shall be allotted, their legal representatives and assigns, subject to the provisions of this Act and the rules and regulations of the corporation:

Provided, however, that the said club may by their rules and regulations allow others to bee me members with re-triefed privileges on such conditions as they think fit.

- 5. The said corporation may from time to time borrow money and at such rate of interest and on such terms as they may deem proper, and foresuch purpose may make, executes and issue any mortgages, bonds, debentures or other instruments under the seal of the said constration, and any such bonds, mortgages, debentures or other instruments shall be signed by such officers as may be designated by the constitution or by-laws of the club.
- 6. Said corporation shall have power to draw, make, accept and cudouse all bills of exchange and promissory notes used sary for the purposes of the said corporation under the hands of such officers as may be designated by the by-laws or constitution of the club, and in no case shall it be necessary that the seal of the translation of the club, and is not easy shall or note nor shall such to the proposition of the same believed to such bill or note nor shall such to the same believed to responsible therefor

Provided that nothing herefit contained shall be construed to authorize the corporation to issue notes or bills of exchange payable to beaper or intended to be circulated as money or as notes or bills of a bank.

- 7. No member of the corporation shall be in any way liable for or chargeable with the payment of any debt or demand due by the said corporation beyond the amount unpaid on any share or the annual subscriptions remaining unpaid by the said member or for any other indebtedness to the chile, and any members of the said club net so indebted to the said corporation may retire therefrom and cease to be a member on ceasing to be a holder of such share and on giving notice to the chile in such form as may be required by the constitution or by-laws of the said club and thenceforth shall be free from any liability for any debt or engagement of the corporation.
- 8. The said corporation shall have full power to erect new buildings or improve their real estate and do all things necessy sary for the earrying out of the objects of the said corporation.

- 9. The persons named in section 1 of this Act shall be the first board of management of the said corporation with full power to administer the affairs thereof until such time as other officers are elected. The affairs of the club shall be managed by a board of seven directors who shall be elected by the members at the annual meeting of the club and who shall be styled the board of ormagement, the number of directors and their term of office being subject to change by the members.
- 10. This Act may be cited as the "Calgary Golf and Country Club Act."
