An Act respecting the Municipal and School Elections of the Cities of Edmonton and Strathcona for the year 1911.

(Assented to

1911.)

WHEREAS the municipal corporations of the Cities of Edmonton and Strathcona have presented a petition praying for the passing of an Act for the amalgamation or union of said corporations under the name of "The City of Edmonton" and for the extension of the boundaries thereof;

And whereas said corporations by another petition allege that it is inexpedient that municipal and school elections should be held in the year 1911 as provided by the Charters of said respective corporations and pray that in view of the said contemplated union the present mayors, aldermen and school trustees of said cities shall hold office until otherwise provided by Act of this Legislative Assembly;

And whereas it is expedient to grant the prayer of said last

mentioned petition;

Therefore His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts

1. Notwithstanding the provisions of any Ordinance or No election for the year one thousand nine hundred and eleven for the election trustees of mayors and aldermen for the Cities of E. cona or for school trustees for the following school districts, namely: The Edmonton School District No. 7 of the Province of Alberta, Saint Joachim Roman Catholic Separate School District No. 7, Strathcona Public School District No. 216, and Saint Anthony de Padua Roman Catholic Separate School District No. 11.

2. The present mayors, aldermen and school trustees for Present mayors, it is and school districts shall hold and they are hereby office to March said cities and school districts shall hold and they are hereby office continued in their respective offices for all intents and purposes 1, 1912. until the first day of March one thousand nine hundred and twelve unless it shall be otherwise provided by any Act passed for the amalgamation or union of the Cities of Edmonton and Strathcona.

3. In the event of no such Act being passed before the first Provision for elections in day of February one thousand nine hundred and twelve the event of councils of the said cities shall respectively forthwith thereafter appoint the returning and other election officers provided passed by The Edmonton Charter and The Strathcona Charter for the holding of municipal and school elections for the election of mayors and the required number of aldermen for said cities and of school trustees for said school districts, and such elections shall be holden as nearly as may be in accordance with the provisions of said charters and the persons so elected shall respectively be mayor, aldermen and school trustees of said cities and school districts and shall hold office in the same manner as if they had been elected as now by law provided.
