An Act to authorize Joseph Boulanger to Practise Medicine.

(Assented to

1912.)

WHEREAS a petition has been presented by Joseph Boulanger, of Grouard, in the district of Athabasca, praying to be allowed to practise the profession of medicine and surgery in the Province of Alberta;

And whereas it appears by the said petition that the said Joseph Boulanger graduated in medicine from the Laval University in Montreal, in the Province of Quebec, and received from that university a diploma as Doctor of Medicine; and it appears that the said Joseph Boulanger has now pursued the practice of medicine in the Province of Alberta for a period covering six (6) years;

And whereas the place at which the petitioner resides is some one hundred (100) miles distant and north of Athabasea Landing in the said province;

And whereas there is no registered practitioner giving his entire time to the general practise of medicine nearer to Grouard aforesaid than the town of Athabasca Landing aforesaid;

And whereas the petitioner asks that an Act be passed to authorize the College of Physicians and Surgeons of the Province of Alberta to admit the petitioner to practise as a physician and surgeon in the said province;

And whereas it has been shown that the said petitioner is otherwise a proper person to be admitted to practise medciine and that it is for the benefit of the residents of the settlement of Grouard where he resides that he should be admitted to practise medicine, surgery and midwifery;

And whereas it is expedient to grant the prayer of the said

Therefore His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. It shall and may be lawful for the College of Physicians and Surgeons of the Province of Alberta to include upon the register of the said college and to authorize the said Joseph Boulanger to pursue the practice of medicine, surgery and midwifery in the said Province of Alberta, and to grant the said Joseph Boulanger such certificate as may enable him to be admitted to practise the profession of medicine, surgery and midwifery in the said Province of Alberta upon the said Joseph Boulanger presenting to the said college satisfactory proof and evidence that the said Joseph Boulanger has duly graduated in medicine from the said Laval University, and upon his paying the proper admission fees on that behalf, exclusive of examination f_{CS} , without his complying with the other requirements and provisions of the law or other rules and regulations of the said College of Physicians and Surgeons of the Province of Alberta in that behalf; any law, custom or usage to the contrary notwithstanding.
