An Act to Provide for the severance from the Town of Nanton of Legal Subdivisions Five (5), Six (6), Seven (7) and Eight (8) in Section Twenty-two (22), Township Sixteen (16), Range Twenty-eight (28), west of the Fourth Meridian, in the Province of Alberta.

W HEREAS at the time of the incorporation of the Town of Nanton legal subdivisions five (5), six (6), seven (7) and eight (8) in section twenty-two (22) in township sixteen (16), range twenty-eight (28), west of cluded in the limits of said town, the said lands being at the time vested in His Majesty the King;

vested in His Majesty the King; And whereas subsequent to the incorporation of the said town and on or about the 8th day of July, 1910, the said lands, excepting the south half of the northeast quarter and the north half of the southeast quarter of said legal subdivision eight (8), were purchased from His Majesty by A. T. LeClair, Esquire, who at the time of the purchase had no knowledge of the fact that the said lands were included in the limits of the town and were therefore subject to taxation for town purposes;

And whereas a considerable portion of the said lands are suitable only for grazing purposes and are used only for grazing and agricultural purposes and under the present system of municipal taxation the taxes on the said lands are entirely out of proportion to the revenue which it is possible to produce from the said lands and there is no good and valid reason why the said lands should be included in the limits of the said town;

And whereas petitions have been presented to the legislative Assembly of the Province of Alberta on behalf of the said Town of Nanton and on behalf of the said A. T. LeClaire, Esquire, praying that a Bill of the said Legislature be enacted to provide for the severance of the said lands from the said town; Therefore His Majesty, by and with the advice and consent of

Therefore His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. That the said lands, namely: Legal subdivisions five (5), six (6), seven (7) and eight (8) of section twenty-two (22) in township sixteen (16), range twenty-eight (28), west of the Fourth Meridian, shall be and the same are hereby severed from and taken out of the limits of the Municipality of the Town of Nanton.

2. That for the purposes of municipal assessment and taxation by the said Town of Nanton the said lands shall be deemed to have been severed from the said Municipality prior to the first day of January, 1913. No. 6
