PROFESSIONAL STATUTES AMENDMENT ACT, 1983

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

Chartered Accountants Act

- 1(1) The Chartered Accountants Act is amended by this section.
- (2) Section 53(3)(d) is repealed and the following is substituted:
 - (d) satisfies the secretary that the company, by law or by virtue of its incorporating documents, has the capacity to carry on the business and exercise the powers set out in the Schedule to this Act;

Dental Association Act

- 2(1) The Dental Association Act is amended by this section.
- (2) Section 75(3)(d) is repealed and the following is substituted:
 - (d) satisfies the registrar that the company, by law or by virtue of its incorporating documents, has the capacity to carry on the business and exercise the powers set out in the Schedule to this Act;

Legal Profession Act

- 3(1) The Legal Profession Act is amended by this section.
- (2) Section 114(3)(d) is repealed and the following is substituted:
 - (d) satisfies the Secretary that the company, by law or by virtue of its incorporating documents, has the capacity to carry on the business and exercise the powers set out in the Schedule to this Act;

Explanatory Notes

Chartered Accountants Act

- (2) Section 53(3)(d) presently reads:
 - (3) The secretary shall issue a permit to any corporation which fulfils the following conditions:
 - (d) satisfies the secretary that the objects of the company stated in its memorandum of association include the objects contained in the Schedule to this Act;

Dental Association Act

- 2(1) This section will amend chapter D-7 of the Revised Statutes of Alberta 1980.
- (2) Section 75(3)(d) presently reads:
 - (3) The registrar shall issue a permit to any corporation which fulfils the following conditions:
 - (d) satisfies the registrar that the objects of the company stated in its memorandum of association include the objects contained in the Schedule to this Act;

Legal Profession Act

- 3(1) This section will amend chapter L-9 of the Revised Statutes of Alberta 1980.
- (2) Section 114(3)(d) presently reads:
 - (3) The Secretary shall issue a permit to any corporation which fulfils the following conditions:
 - (d) satisfies the Secretary that the objects of the company stated in its memorandum of association include the objects contained in the Schedule to this Act;

Medical Profession Act

- 4(1) The Medical Profession Act is amended by this section.
- (2) Section 65(1)(d) is repealed and the following is substituted:
 - (d) satisfies the registrar that the company, by law or by virtue of its incorporating documents, has the capacity to carry on the business and exercise the powers set out in the Schedule to this Act;

In accordance with section 4(1) of the Interpretation Act, this Bill comes into force on the date it receives Royal Assent.

Medical Profession Act

- (2) Section 65(1)(d) presently reads:

 - (d) satisfies the registrar that the objects of the company stated in its memorandum of association include the objects contained in the Schedule to this Act;
