EDMONTON CONVENTION CENTRE AUTHORITY AMENDMENT ACT, 1983

(Assented to , 1983)

WHEREAS the Edmonton Convention Centre Authority was incorporated by chapter 75 of the Statutes of Alberta, 1979; and

WHEREAS the City of Edmonton has presented a petition praying that the Act be amended as herein set forth and it is expedient to grant the prayer of the petition;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

- 1 The Edmonton Convention Centre Authority Act is amended by this Act.
- 2 Section 6 is amended in clause (d) by striking out "5" and substituting "7".
- 3 Section 7(3) and (4) are repealed and the following is substituted:
 - (3) The 7 persons appointed pursuant to section 6(d) shall be appointed for terms commencing on the day of their appointment and shall be appointed so that:
 - (a) the term of 3 members shall end on the last day of December of the 3rd year following their appointment;
 - (b) the term of 2 members shall end on the last day of December of the 2nd year following their appointment;
 - (c) the term of 2 members shall end of the last day of December of the first year following their appointment.

Explanatory Notes

- 1 This Bill will amend chapter 75 of the Statutes of Alberta, 1979.
- **2** Section 6 presently reads in part:
 - 6 The Authority shall be composed of
 - (d) 5 electors appointed by the Council.
- **3** Section 7(3) and (4) presently read:
 - (3) The 5 electors who are first appointed as members of the Authority shall be appointed for terms commencing on the day of their appointment and they shall be appointed so that
 - (a) the term of one member shall end on the day on which the 3rd organizational meeting of the Council following his appointment is held,
 - (b) the term of 2 members shall end on the day on which the 2nd organizational meeting of the Council following his appointment is held, and

(4) A member of the Council or a person appointed to succeed a member appointed pursuant to subsections (2) or (3) shall be appointed for a term of 1 year, unless he is being reappointed, in which case the reappointment shall be for a term in accordance with subsection (3)(a) or (b), subject to section 8.

In accordance with section 4(1) of the Interpretation Act, this Bill comes into force on the date it receives Royal Assent.

- (c) the term of 2 members shall end on the day on which the first organizational meeting of the Council following his appointment is held.
- (4) A member of Council or an elector appointed to succeed a person appointed pursuant to subsection (2) or (3) shall be appointed for a term of one year, subject to section 8.
