ALBERTA ART FOUNDATION AMENDMENT ACT, 1984

(Assented to

, 1984)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

- 1 The Alberta Art Foundation Act is amended by this Act.
- 2 Section 1 is amended by adding the following after clause (b):
 - (b.1) "public art gallery" means a public art gallery as prescribed in the regulations;
- 3 Section 3 is amended by adding the following after clause (a):
 - (a.1) public art galleries in Alberta may be encouraged in their work,
- 4 The following is added after section 4:
 - **4.1** The Minister may make regulations prescribing public art galleries for the purposes of section 1(b.1).
- 5 The following is added after section 5(1)(c):
 - (d) make grants to any person or organization carrying on activities that are within the objects of the Foundation.
- 6 Section 6(1) is repealed.

Explanatory Notes

1	This Bill amends chapter A-15 of the Revised Statutes of Alberta 1980.

6	Section 6(1) presently reads:
	6(1) The Provincial Treasurer shall pay to the Foundation in each year a grant in the sum of \$50 000 from the General Revenue Fund.
	(2) The Foundation may accept any gift, bequest or devise of real or personal property subject to any conditions prescribed by the person making the gift or by the will or other instrument under which the real or personal property is acquired.

(3) All expenditures made by the Foundation shall be paid by it from its own funds.

- 7 Section 8(3)(a) is amended by striking out "acquisition of works of art" and substituting "exercise of its powers".
- 8 Section 6 is deemed to have come into force on March 31, 1984.

In accordance with section 4(1) of the Interpretation Act, this Bill, except section 6, comes into force on the date it receives Royal Assent.

- 7 Section 8(3)(a) presently reads:
 - (3) The Minister may give directions to the Foundation for the purpose of

 (a) providing priorities and guidelines for it to follow in the acquisition of works of art, and
