JEWISH COMMUNITY CENTRE OF EDMONTON ACT

(Assented to , 1984)

WHEREAS the Jewish Community Centre of Edmonton has presented a petition praying that it be enacted as herein set forth and it is expedient to grant the prayer of the petition;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

Exemption from taxes

1 Each of the following lands and buildings in the City of Edmonton which are owned by the Jewish Community Centre of Edmonton and described as follows:

(a) LOT ONE (1) IN A SUBDIVISION OF PART OF THE EAST HALF OF SECTION TWENTY TWO (22) TOWNSHIP FIFTY TWO (52) RANGE TWENTY FIVE (25) WEST OF THE FOURTH MERIDIAN, AS PLAN 8069 E.T. CONTAINING SEVEN AND SIXTY SEVEN HUNDREDTHS (7.67) ACRES MORE OR LESS EDMONTON

RESERVING THEREOUT ALL MINES AND MINERALS;

(b) ALL THAT PORTION OF BLOCK (X) ON PLAN 3822 A.R., WHICH LIES EAST OF THE EAST BOUNDARY OF LOT ONE (1) ON PLAN 8069 E.T. THE LAND HEREBY DESCRIBED CONTAINING THREE AND THIRTY FOUR HUNDREDTHS (3.34) ACRES MORE OR LESS (S.E. 22-52-25-W.4TH)

EXCEPTING THEREOUT ALL MINES AND MIN-ERALS; (c) ALL THAT PORTION OF THE SOUTH EAST QUARTER OF SECTION TWENTY TWO (2[°]) TOWNSHIP FIFTY TWO (52) RANGE TWENTY FIVE (25) WEST OF THE FOURTH MERIDIAN NOT COVERED BY ANY OF THE WATERS OF THE SAS-KATCHEWAN RIVER, AS SHOWN ON A PLAN OF SUR-VEY OF SAID TOWNSHIP SIGNED AT OTTAWA ON THE 11TH DAY OF OCTOBER A.D. 1897, BOUNDED AS FOL-LOWS:

> ON THE EAST BY THE EAST BOUNDARY OF THE SAID QUARTER SECTION—ON THE NORTH BY THE SOUTH WEST BOUNDARY OF BLOCK (X) AS SHOWN ON SUBDIVISION PLAN 3822 A.R. ON THE WEST BY THE EAST BOUNDARY OF LOT ONE (1) AS SHOWN ON SUBDIVISION PLAN 8069 E.T. AND ON THE SOUTH BY THE PRO-DUCTION EASTERLY OF THE SOUTH BOUND-ARY OF THE SAID LOT ONE (1)

THE LAND HEREBY DESCRIBED CONTAINING FIVE AND THIRTY HUNDREDTHS (5.30) ACRES, MORE OR LESS

RESERVING UNTO HER MAJESTY ALL MINES AND MINERALS

shall be exempt from all municipal and school taxes of every nature whatsoever, with effect from January 1, 1984, for so long as the lands are registered in the name of the Jewish Community Centre of Edmonton and used for the fulfillment of its objects.

In accordance with section 4(1) of the Interpretation Act, this Bill comes into force on the date it receives Royal Assent.
