CITY OF EDMONTON AUTHORITIES AMENDMENT ACT, 1985

(Assented to , 1985)

WHEREAS The Edmonton Convention Centre Authority was incorporated by chapter 75 of the Statutes of Alberta, 1979, as amended by chapter 58 of the Statutes of Alberta, 1983 and chapter 74, of the Statutes of Alberta, 1984; and

WHEREAS The Edmonton Research and Development Park Authority was incorporated by chapter 93 of the Statutes of Alberta, 1980, as amended by chapter 75 of the Statutes of Alberta, 1984; and

WHEREAS The Edmonton Ambulance Authority was incorporated by chapter 87 of the Statutes of Alberta, 1981; and

WHEREAS the Edmonton Convention and Tourism Authority was incorporated by chapter 37 of the Statutes of Alberta, 1982, as amended by chapter 59 of the Statutes of Alberta, 1983; and

WHEREAS the Edmonton Economic Development Authority was incorporated by chapter 38 of the Statutes of Alberta, 1982; and

WHEREAS the City of Edmonton has presented a petition praying for further amendments to the aforesaid Acts as herein set forth, and it is expedient to grant the prayer of the petition;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

- 1(1) The Edmonton Convention Centre Authority Act is amended by this section.
- (2) Section 6(b) is repealed and the following is substituted:
 - (b) the City Manager or other member of the City administration appointed by the Council,

Explanatory Notes

- 1(1) This section will amend chapter 75 of the Statutes of Alberta, 1979.
- (2) Section 6(b) presently reads:
 - (b) A Commissioner of the City, appointed by the Council,

- (3) Section 7 is amended
 - (a) by repealing subsection (1) and substituting:
 - (1) The members of the Authority, apart from the Mayor, shall be appointed by the Council for a term of 1 year.
 - (b) by repealing subsections (2), (3) and (4).

- 2(1) The Edmonton Research and Development Park Authority Act is amended by this section.
- (2) Section 6(1)(b) is repealed and the following is substituted:
 - (b) the City Manager or other member of the City administration appointed by the Council,

- (3) Section 7 presently reads:
 - 7(1) As soon as practically possible after this Act comes into force the Council shall appoint the first members of the Authority pursuant to section 6(c) and (d).
 - (2) The members of the Council who are first appointed as members of the Authority shall be appointed for a term commencing on the day of their appointment and ending on the day on which the first organizational meeting of the Council following their appointment is held.
 - (3) The 7 persons appointed pursuant to section 6(d) shall be appointed for terms commencing on the day of their appointment and shall be appointed so that:
 - (a) the term of 3 members shall end on the last day of December of the 3rd year following their appointment;
 - (b) the term of 2 members shall end on the last day of December of the 2nd year following their appointment;
 - (c) the term of 2 members shall end of the last day of December of the first year following their appointment.
 - (4) A member of the Council or a person appointed to succeed a member appointed pursuant to subsections (2) or (3) shall be appointed for a term of 1 year, unless he is being reappointed, in which case the reappointment shall be for a term in accordance with subsection (3)(a) or (b), subject to section 8.
 - (5) Notwithstanding the period for which he was appointed as a member of the Authority, a member of the Council may hold office as a member of the Authority only so long as he remains a member of the Council.
 - (6) Subject to subsection (5) and notwithstanding the period for which he was appointed as a member of the Authority, a member of the Authority shall remain in office until his successor has been appointed, unless disqualified pursuant to section 9.
 - (7) A former member of the Authority is eligible for reappointment as a member of the Authority.
- **2(1)** This section will amend chapter 93 of the Statutes of Alberta, 1980.
- (2) Section 6(1)(b) presently reads:
 - (b) one Commissioner of the City appointed by the Council,

- (3) Section 7 is amended
 - (a) by repealing subsection (1) and substituting:
 - (1) The members of the Authority, apart from the Mayor, shall be appointed by the Council for a term of 1 year.
 - (b) by repealing subsections (2), (3), (4), (5) and (7);
 - (c) in subsection (8) by striking out "Subject to subsection (4)" and substituting "Subject to subsection (6)".

- (3) Section 7 presently reads:
 - 7(1) As soon as practically possible after this Act comes into force the first members of the Authority shall be appointed.
 - (2) The member of the Council who is first appointed as a member of the Authority shall be appointed for a term commencing on the day of his appointment and ending on the day on which the first organizational meeting of the Council following his appointment is held.
 - (3) The 5 electors who are first appointed as members of the Authority shall be appointed for terms commencing on the day of their appointment and they shall be appointed so that
 - (a) the term of 2 members shall be 3 years,
 - (b) the term of 2 members shall be 2 years, and
 - (c) the term of one member shall be one year.
 - (4) A member of the Council or an elector appointed to succeed a person appointed pursuant to subsection (2) or (3) shall be appointed for a term of one year, subject to section 8.
 - (5) The term of an elector appointed pursuant to section 6(2) shall be determined by the Council at the time of his appointment but shall not exceed 3 years.
 - (6) Notwithstanding the period for which he was appointed as a member of the Authority, a member of the Council may hold office as a member of the Authority only so long as he remains a member of the Council.
 - (7) A member appointed pursuant to section 6(1)(e), (f) or (g) shall be appointed for a term of one year.
 - (8) Subject to subsection (4) and notwithstanding the period for which he was appointed as a member of the Authority, a member of the Authority shall remain in office until his successor has been appointed, unless disqualified pursuant to section 9.
 - (9) A former member of the Authority is eligible for reappointment as a member of the Authority.

- 3(1) The Edmonton Ambulance Authority Act is amended by this section.
 - (2) Section 6(b) is repealed and the following is substituted:
 - (b) the City Manager or other member of the City administration appointed by the Council;
- (3) Section 7 is amended
 - (a) by repealing subsection (1) and substituting:
 - (1) The members of the Authority, apart from the Mayor and the Medical Officer of Health for the City, shall be appointed by the Council for a term of 1 year.
 - (b) by repealing subsections (2), (3), (4) and (6).

- **3**(1) This section will amend chapter 87 of the Statutes of Alberta, 1981.
- (2) Section 6(b) presently reads:
 - (b) one Commissioner of the City appointed by the Council;
- (3) Section 7 presently reads:
 - 7(1) As soon as practically possible after this Act comes into force the first members of the Authority shall be appointed.
 - (2) An elector or member of the Council appointed a first member of the Authority in accordance with subsection (1), shall be appointed for a term commencing on the day of his appointment and ending on the day on which the first organizational meeting of the Council following his appointment is held.
 - (3) An elector appointed to succeed a person appointed pursuant to subsection (2) may be appointed for a term not to exceed 3 years, subject to section 8, and Council may vary the term of appointment from elector to elector.
 - (4) A member of Council appointed to succeed a person appointed pursuant to subsection (2) shall be appointed for a term of 3 years, subject to section 8.
 - (5) Notwithstanding the period for which he was appointed as a member of the Authority, a member of the Council may hold office as a member of the Authority only so long as he remains a member of the Council.
 - (6) A member appointed pursuant to section 6(d) or (e) shall be appointed for a term of one year.
 - (7) Subject to subsection (5) and notwithstanding the period for which he was appointed as a member of the Authority, a member of the Authority shall remain in office until his successor has been appointed, unless disqualified pursuant to section 9.
 - (8) A former member of the Authority is eligible for reappointment as a member of the Authority.

- 4(1) The Edmonton Convention and Tourism Authority Act is amended by this section.
- (2) Section 6 is amended
 - (a) in subsection (2) by striking out "(a),";
 - (b) by adding the following after subsection (2):
 - (2.1) The term of a member appointed under section 5(a) shall be 1 year.

5(1) The Edmonton Economic Development Authority Act is amended by this section.

- (9) The Authority may provide for the payment of reasonable remuneration or of a gratuity or allowance to members of the Authority.
- **4**(1) This section will amend chapter 37 of the Statutes of Alberta, 1982.
- (2) Section 6 presently reads:
 - 6(1) As soon as practically possible after this Act comes into force the first members of the Authority shall be appointed.
 - (2) The initial term of members appointed under section 5(a), (c), (e), (h) and (i) shall be 2 years from the date of their appointment.
 - (3) The initial term of members appointed under section 5(b), (d) and (g) shall be 1 year from the date of their appointment.
 - (4) The Authority shall specify an initial term not to exceed 2 years for every member appointed under section 5(j).
 - (5) The Mayor shall be a member throughout his term of office.
 - (6) Except as otherwise provided in this section, the term of office of a member shall be 2 years.
 - (7) Notwithstanding the period for which he was appointed as a member of the Authority, a member of the Council may hold office as a member of the Authority only so long as he remains a member of the Council.
 - (8) Notwithstanding the period for which he was appointed as a member of the Authority, a member of the Authority shall remain in office until his successor has been appointed, unless disqualified pursuant to section 8.
 - (9) A former member of the Authority is eligible for reappointment as a member of the Authority.
- **5(1)** This section will amend chapter 38 of the Statutes of Alberta, 1982.
 - (2) Section 5(b) is repealed and the following is substituted:
 - (b) the City Manager or other member of the City administration appointed by the Council;

- (3) Section 6 is amended by adding the following after subsection (8):
 - (9) Except as otherwise provided in this section, the term of office of a member appointed under section 5(a) and (b) shall be 1 year and under 5(c) and (d) shall be 2 years.

In accordance with section 4(1) of the Interpretation Act, this Bill comes into force on the date it receives Royal Assent.

- (2) Section 5(b) presently reads:
 - (b) 1 City commissioner appointed by the Council;
- (3) Section 6 presently reads:
 - 6(1) As soon as practically possible after this Act comes into force the first members of the Authority shall be appointed.
 - (2) The initial term of members appointed under section 5(a), (b) and (c) shall be 3 years from the date of their appointment.
 - (3) The initial term of members appointed under section 5(d) shall be 2 years from the date of their appointment.
 - (4) The Mayor shall be a member throughout his term of office.
 - (5) Notwithstanding the period for which he was appointed as a member of the Authority, a member of the Council may hold office as a member of the Authority only so long as he remains a member of the Council.
 - (6) Notwithstanding the period for which he was appointed as a member of the Authority, a member of the Authority shall remain in office until his successor has been appointed, unless disqualified pursuant to section 8.
 - (7) A former member of the Authority is eligible for reappointment as a member of the Authority.
 - (8) Notwithstanding subsection (3), the members appointed under that subsection may have their terms extended for a further period of 1 year or less so as to ensure that in any given year, the number of vacancies among the members of the Authority, due to expiration of term, shall not exceed 4.
