## **DEPARTMENT OF CULTURE AMENDMENT ACT, 1987**

(Assented to , 1987)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

1 The Department of Culture Act is amended by this Act.

2 The title of the Act is amended by adding "AND MULTICULTUR-ALISM" after "CULTURE".

3 Section 1(a) and (b) are amended by adding "and Multiculturalism" after "Culture".

4 Section 2 is amended by adding "and Multiculturalism" after "Culture" wherever it occurs.

5 Section 3 is amended by adding "and Multiculturalism" after "Culture".

6 Section 7 is amended by adding "or multicultural" after "cultural".

7 Section 9(1) is amended by adding "and Multiculturalism" after "Culture".

#### **Explanatory Notes**

- 1 This Bill will amend chapter D-15 of the Revised Statutes of Alberta 1980.
- **2** The title of the Act presently reads:

DEPARTMENT OF CULTURE ACT

- **3** Section 1 presently reads:
  - 1 In this Act,
    - (a) "Department" means the Department of Culture;
    - (b) "Minister" means the Minister of Culture.
- **4** Section 2 presently reads:

2 There shall be a department of the Government called the Department of Culture over which shall preside the member of the Executive Council appointed by the Lieutenant Governor under the Great Seal of the Province as Minister of Culture.

**5** Section 3 presently reads:

3 In accordance with the Public Service Act there may be appointed a Deputy Minister of Culture and other employees required to conduct the business of the Department.

**6** Section 7 presently reads:

7 The Minister may on behalf of the Government of Alberta enter into agreements with the Government of Canada, the government of a province of Canada, the government of a foreign jurisdiction, an agency of any of those governments, a municipal corporation in Alberta or any other person in respect of matters concerning the cultural development of Alberta or historical resources in Alberta.

7 Section 9(1) presently reads:

9(1) The Minister shall establish and administer a revolving fund for the Department of Culture.

8 Section 10(1) is amended by adding "or multiculturalism" after "culture".

9 In the following provisions, "and Multiculturalism" is added after "Culture":

    - (b) in accordance with the regulations,
