HISTORICAL RESOURCES AMENDMENT ACT, 1987

(Assented to , 1987)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

- 1 The Historical Resources Act is amended by this Act.
- 2 Section 28 is amended
 - (a) in subsection (1) by striking out "The" and substituting "Subject to subsections (2) and (3), the";
 - (b) by adding the following after subsection (2):
 - (3) The Minister may, in accordance with the regulations, sell, lease, exchange or otherwise dispose of any archaeological or palaeontological resource on any terms he considers appropriate.
- 3 Section 29 is amended
 - (a) by renumbering it as section 29(1);
 - (b) in subsection (1) by striking out "No" and substituting "Subject to subsection (2), no";
 - (c) by adding the following after subsection (1):
 - (2) Subsection (1) does not apply to an archaeological or palaeontological resource that has been sold, leased, exchanged or otherwise disposed of by the Minister pursuant to section 28(3).
- 4 Section 30 is amended
 - (a) by renumbering it as section 30(1);
 - (b) in subsection (1) by striking out "No" and substituting "Subject to subsection (2), no";
 - (c) by adding the following after subsection (1):
 - (2) Subsection (1) does not apply to an archaeological or palaeontological resource that has been sold, leased, exchanged or otherwise disposed of by the Minister pursuant to section 28(3).

Explanatory Notes

- 1 This Bill will amend chapter H-8 of the Revised Statutes of Alberta 1980.
- 2 Section 28 presently reads:
 - 28(1) The property in all archaeological resources and palaeontological resources within Alberta is vested in the Crown in right of Alberta.
 - (2) No sale or other disposition of land belonging to the Crown in right of Alberta shall operate as a conveyance of an archaeological resource or palaeontological resource situated on or under the land unless the sale or other disposition expressly states that it does so operate.
- 3 Section 29 presently reads:
 - 29 No person shall transport any of the following out of Alberta without the written permission of the Minister:
 - (a) archaeological resources;
 - (b) palaeontological resources;
 - (c) historic resources that are the subject of an order under section 15 or 16.
- 4 Section 30 presently reads:
 - 30 No person shall alter, mark or damage an archaeological resource or palaeontological resource unless he is the holder of a valid permit under section 26 or has the written permission of the Minister to do so.

- 5 Section 31 is repealed and the following is substituted:
 - 31 The Minister may make regulations
 - (a) respecting the sale, lease, exchange or disposition of archaeological and palaeontological resources;
 - (b) exempting any person or class of person from the operation of section 29(1) or 30(1).
- 6 Section 34 is amended
 - (a) in subsection (1) by striking out "of 9 persons";
 - (b) by repealing subsection (2) and substituting the following:
 - (2) The board shall consist of not more than 11 directors appointed by the Lieutenant Governor in Council to serve for the terms designated in their respective appointments.
- 7 The heading before section 45 is amended by striking out "PART 5" and substituting "PART 4".

- 5 Section 31 presently reads:
 - 31 The Minister may make regulations exempting any person or class of persons from the operation of section 29 or 30.
- 6 Section 34 presently reads in part:
 - 34(1) There is hereby established a corporation with the name "The Alberta Historical Resources Foundation" consisting of a board of directors of 9 persons and the other persons that become members of the Foundation.
 - (2) The board shall consist of
 - (a) 6 directors appointed by the Lieutenant Governor in Council to serve for the term designated in their respective appointments, and
 - (b) 3 directors elected by the members from the general membership to serve for a period of 2 years.
