### **UNITED FARMERS OF ALBERTA CO-OPERATIVE LIMITED AMENDMENT ACT, 1987**

*(Assented to , 1987)*

WHEREAS the United Farmers of Alberta Co-operative Limited was incorporated by chapter 56 of the Statutes of Alberta, 1918, which was revised and consolidated with subsequent amending Acts by chapter 124 of the Statutes of Alberta, 1966; and

WHEREAS a petition has been presented praying that the latter Act be amended as herein set forth and it is expedient the grant the prayer of the petition;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

*1 The United Farmers of Alberta Co-operative Limited Act, 1966 is amended by this Act.*

*2 Section 3 is repealed and the following is substituted:*

**3(1)** The objects of the Association are to co-operate and assist in promoting the economic and cultural welfare of the farmers and ranchers of Alberta and to assist and co-operate with other farm organizations, institutions and groups in programs designed to improve the position of the farmers and ranchers of Alberta.

(2) The Association has, and shall be deemed to have always had, capacity to accept powers to effect its objects and purposes outside Alberta from any authority lawfully competent to confer those powers.

## Explanatory Notes

### Preamble

1 This Bill with amend chapter 124 of the Statutes of Alberta, 1966.

2 Section 3 presently reads:

*3 The objects of the Association are to co-operate and assist in promoting the economic and cultural welfare of farmers and ranchers in Alberta and to assist and co-operate with other farm organizations, institutions and groups in programs designed to improve the position of farmers and ranchers in Alberta.*

3 *Section 4 is amended in subsection (1)(e) by striking out “within Alberta”.*

4 *Section 12 is amended*

*(a) by striking out “1946.” and substituting “1946;”, and*

*(b) by adding the following after “1946;”*

Chapter 94 of the Statutes of Alberta, 1948;

Chapter 119 of the Statutes of Alberta, 1949.

**3** Section 4(1)(e) presently reads:

*4(1) The Association is empowered*

*(e) to purchase, lease or otherwise acquire and hold real and personal property within Alberta necessary for the purposes of the Association and to sell, mortgage, lease, exchange or otherwise deal with it or any part thereof as the Association considers proper or advisable,*

**4** section 12 presently reads:

*12 The following Acts are repealed:*

*Chapter 56 of the Statutes of Alberta, 1918;*

*Chapter 78 of the Statutes of Alberta, 1944;*

*Chapter 76 of the Statutes of Alberta, 1946.*
