### **EDMONTON CONVENTION AND TOURISM AUTHORITY AMENDMENT ACT, 1987**

*(Assented to , 1987)*

WHEREAS the Edmonton Convention and Tourism Authority was incorporated by chapter 37 of the Statutes of Alberta, 1982 which was amended by chapter 59 of the Statutes of Alberta, 1983 and chapter 56 of the Statutes of Alberta, 1985; and

WHEREAS the City of Edmonton has presented a petition praying that the Act be further amended as herein set forth and it is expedient to grant the prayer of the petition;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

*1 The Edmonton Convention and Tourism Authority Act is amended by this Act.*

*2 Section 5 is amended:*

*(a) by repealing clause (g) and substituting:*

*(g) 1 elector to be selected by the members of the Authority described in clauses (a) through (f) who shall represent the City's festival groups;*

*(b) in clauses (h) and (i) by striking out "(g)" and substituting "(f)";*

*(c) by adding the following after clause (j):*

*(j.1) not more than 5 electors appointed by the Council, each of whom shall:*

*(i) meet the qualifications of either clause (h) or (i), or*

## **Explanatory Notes**

### **Preamble**

**1** This Bill will amend chapter 37 of the Statutes of Alberta, 1982.

**2** Section 5 presently reads as follows:

*5 The authority shall be composed of:*

*(a) 2 electors appointed by the Council, 1 of whom may be a member of the Council;*

*(b) 1 elector appointed by The Edmonton Chamber of Commerce;*

*(c) 1 elector appointed by Alberta Hotel Association;*

*(d) 1 elector appointed by The Alberta Restaurant and Food Services Association;*

*(e) 1 elector appointed by The Edmonton Exhibition Association Limited;*

(ii) be a general member who is on the City's assessment roll and liable to pay business or property taxes to the City or is an officer or director of such a general member; and

*3 The following is added after section 5:*

**5.1** In making appointments under clause 5(k), the Council shall provide to the Authority a reasonable opportunity to make suggestions for each such appointment.

*(f) 1 elector appointed by The Edmonton Convention Centre Authority;*

*(g) 1 elector appointed by the Committee designated by the Council to deal with special events in the City;*

*(h) 1 elector to be selected by the members of the Authority described in clauses (a) through (g) who shall represent the City's heritage, cultural and special attraction groups;*

*(i) 1 elector to be selected by the members of the Authority described in clauses (a) through (g) who shall be experienced in the convention and tourism industry;*

*(j) not more than 5 electors appointed by the Authority each of whom shall:*

*(i) meet the qualifications of either clause (h) or (i), or*

*(ii) be a general member who is on the City's assessment roll and liable to pay business or property taxes to the City or is an officer or director of such a general member;*

*(k) the Mayor.*

**3** New section to provide Authority opportunity to make suggestions for appointments.
