APPROPRIATION (ALBERTA CAPITAL FUND) ACT, 1989

(Assented to _____, 1989)

MOST GRACIOUS SOVEREIGN:

Preamble

WHEREAS it appears by a Message from Her Honour, W. Helen Hunley, Lieutenant Governor of the Province of Alberta, and the Estimates accompanying the Message, that the sum hereinafter mentioned is required to defray certain expenditures of the Public Service of Alberta not otherwise provided for during the fiscal years ending March 31, 1989 and March 31, 1990, and for other purposes relating thereto:

MAY IT THEREFORE PLEASE YOUR MAJESTY that it be enacted and be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Alberta, as follows:

Appropriation for
1988-89

1 From and out of the Alberta Capital Fund, there may be paid and applied a sum not exceeding in the whole \$4 000 000 towards defraying the several charges and expenses of the Public Service from April 1, 1988 to March 31, 1989, not otherwise provided for and set forth in Schedule "A" to this Act.

Appropriation for
1989-90

2 From and out of the Alberta Capital Fund, there may be paid and applied a sum not exceeding, in the whole, \$305 928 000 towards defraying the several charges and expenses of the Public Service from April 1, 1989 to March 31, 1990 not otherwise provided for and set forth in Schedule "B" to this Act, including the amount of \$158 699 000 voted by section 1 of the *Appropriation (Alberta Capital Fund) Interim Supply Act, 1989*.

3 The due application of all money expended under this Act shall be accounted for.
