### **AGRICULTURAL RESOURCES CONSERVATION BOARD ACT**

*(Assented to*

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

Definitions

**1** In this Act,

(a) "agricultural land" means land that is being farmed and is zoned for farming and has been farmed during the 3 years.

(b) farming includes the production of crops, feed, tree seedling; the raising of livestock including for other than natural growth, and fallowing in the norm of good husbandry.

Board established

**2** There is hereby established a board to be known as the Agricultural Resources Conservation Board.

Members

**3** The Board shall consist of 9 members appointed by the Lieutenant Governor in Council.

Objects

**4** The objects of the Board are

(a) to provide advice, education, co-ordination and assistance with respect to the use, conservation, enhancement and expansion of agricultural land;

(b) to encourage the minimization of use of good agricultural land for other purposes;

(c) to carry out and encourage research and development of agricultural practices that will protect and recover agricultural resources.

land.

- Powers**            **5**    The Board may carry out or contract for studies related to its objects or enter into agreements to assist in the achievements of its objects by any means it deems appropriate.
- Use of land**        **6**    Notwithstanding any other Act, no person or authority that has the power to authorize a change in the use of land shall permit agricultural land to be put to any use that is not farming unless he or it has first received a report on the land from the Board.
- Remuneration, staff**    **7(1)** The members of the Board shall receive such remuneration and the reimbursement of such expenses as are specified by order of the Lieutenant Governor in Council, providing that money has been appropriated to that purpose by the Legislature.
- (2)** The Board may employ such staff and retain such advisors as it deems necessary providing that money has been appropriated to that purpose by the Legislature.
- Financial statement and annual report**    **8**    The Board shall, in respect of each year, submit a financial statement and annual report to the Minister of Agriculture who shall forthwith lay them before the Legislative Assembly if it is then sitting, or if it is not sitting, within 30 days of the commencement of the next sitting.
- Crown bound**        **9**    This Act binds the Crown.
