EDMONTON RESEARCH AND DEVELOPMENT PARK AUTHORITY AMENDMENT ACT, 1990

(Assented to , 1990)

WHEREAS the Edmonton Research and Development Park Authority was incorporated by chapter 93 of the Statutes of Alberta, 1980, which was amended by chapter 75 of the Statutes of Alberta, 1984 and chapter 56 of the Statutes of Alberta, 1985; and

WHEREAS the Edmonton Research and Development Park Authority has presented a petition praying for further amendments as herein set forth, and it is expedient to grant the prayer of the petition;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

1 The Edmonton Research and Development Park Authority Act is amended by this Act.

2 Section 1(h) is repealed and the following is substituted:

(h) "Minister" means the Minister of Technology, Research and Telecommunications, or the Minister who is subsequently assigned responsibility for research and technology development.

3 Section 4(f) is amended by adding "and services" after "any goods".

4 Section 6 is amended:

(a) by repealing clause (1)(b);

(b) by adding the following after clause (1)(a):

(c) *by adding the following at the end of subsection (9):*

"and such re-appointment shall be made upon the recommendation of the body represented by the member."

6 *Section 8 is amended by adding "upon the recommendation of the body represented by the vacant position." after "the Council shall".*
