### LA SOCIETE DE BIENFAISANCE CHAREVE TAX EXEMPTION ACT

(Assented to \_\_\_\_\_, 1990)

WHEREAS La Societe de Bienfaisance Chareve was incorporated pursuant to the *Societies Act* on May 27, 1986, and is designated as a charitable organization, for the purposes of *The Income Tax Act* (Canada) and

WHEREAS a petition has been presented praying that it be enacted as herein set forth and it is expedient to grant the prayer of the petition.

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

1. The following lands and buildings in the Village of Radway registered in the name of La Societe de Bienfaisance Chareve and described as follows:

ALL THAT PORTION OF THE NORTH EAST QUARTER  
OF  
SECTION THIRTY TWO (32)  
TOWNSHIP FIFTY EIGHT (58)  
RANGE TWENTY (20)  
WEST OF THE FOURTH MERIDIAN  
LYING NORTH OF THE CANADIAN NORTHERN  
WESTERN RAILWAYS RIGHT-OF-WAY AS SHOWN ON  
RAILWAY PLAN 371 B.V.,  
CONTAINING 19.235 HECTARES (947.58 ACRES) MORE  
OR LESS.  
EXCEPTING THEREOUT:  
a. 0.93 HECTARES (0.23 ACRE) MORE OR LESS AS  
SHOWN ON ROAD PLAN 1144 E.T.

b. 1.133 HECTARES (2.80 ACRES) MORE OR LESS FOR ROAD AS SHOWN ON ROAD PLAN 2825 J.Y.

c. 0.672 HECTARES 9(1.66 ACRES) MORE OR LESS, SUBDIVIDED UNDER PLAN 6128 K.S.

d. 0.405 HECTARES (1 ACRE) MORE OR LESS, SUBDIVIDED UNDER PLAN 2787 M.C.

EXCEPTING THEREOUT ALL MINES AND MINERALS.

are exempt from assessment and all municipal taxation except local improvement taxes with effect from January 1, 1989, for so long as the lands are registered in the name of La Societe de Bienfaisance Chareve and used for the provision of recreational, social, cultural, educational, religious and charitable facilities to the general public on a non-profit basis.
