### FOREST DEVELOPMENT RESEARCH TRUST FUND AMENDMENT ACT, 1991

(Assented to \_\_\_\_\_, 1991)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

*1 The Forest Development Research Trust Fund Act is amended by this Act.*

*2 Section 1(a) is amended by adding "Alberta" after "means the".*

*3 Section 2(2) is amended by striking out "research programs oriented toward improved forest management and timber production" and substituting "programs respecting forest research".*

*4 Section 3 is amended*

*(a) in subsection (1) by striking out "a" and substituting "an Alberta";*

*(b) in subsection (4)*

*(i) by repealing clauses (a) and (b) and substituting the following:*

*(a) the Regional Director General of the Northern Forestry Centre of Forestry Canada,*

*(b) the Dean of the Faculty of Agriculture and Forestry of the University of Alberta,*

## Explanatory Notes

**1** This Bill will amend chapter F-13 of the Revised Statutes of Alberta 1980.

**2** Section 1(a) presently reads:

*1 In this Act,*

*(a) "Council" means the Forest Research Advisory Council appointed by the Minister;*

**3** Section 2(2) presently reads:

*(2) The Minister, on the advice of the Council, shall make payments from the Fund to finance research programs oriented toward improved forest management and timber production.*

**4** Section 3(1) and (4) presently read:

*3(1) The Minister shall appoint a Forest Research Advisory Council of not less than 11 members.*

*(4) Other members of the Council shall include:*

*(a) the Director of the Northern Forest Research Centre in the Department of the Environment of the Government of Canada,*

*(b) the Chairman of the Department of Forest Science in the Faculty of Agriculture and Forestry of The University of Alberta,*

*(c) the Assistant Deputy Minister, Alberta Forest Services,*

- (ii) *in clause (c) by striking out “Services” and substituting “Service”;*
- (iii) *in clause (e) by striking out “The Research Council of Alberta” and substituting “the Alberta Research Council”.*

*(d) one representative nominated by the Alberta Forest Products Association, and*

*(e) one representative nominated by The Research Council of Alberta.*
