**APPROPRIATION (ALBERTA CAPITAL FUND)
INTERIM SUPPLY ACT, 1992**

MOST GRACIOUS SOVEREIGN:

Preamble WHEREAS it appears by a Message from His Honour, Gordon Towers, Lieutenant Governor of the Province of Alberta, and the Schedule accompanying the Message, that the sum hereinafter mentioned is required to defray certain expenditures of the Public Service of Alberta not otherwise provided for during the fiscal year ending March 31, 1993, and for other purposes relating thereto:

MAY IT THEREFORE PLEASE YOUR MAJESTY that it be enacted and be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Alberta, as follows:

Appropriation for 1992-93 **1** From and out of the Alberta Capital Fund, there may be paid and applied a sum not exceeding \$121 474 000 towards defraying the several charges and expenses of the Public Service from April 1, 1992 to March 31, 1993, not otherwise provided for and being the aggregate of the amounts enumerated in the Schedule to this Act.

Accountability **2** The due application of all money expended under this Act shall be accounted for.
