(Assented to _____, 1993)

HER MAJESTY, by and with the advice and consent of the
Legislative Assembly of Alberta, enacts as follows:

Part 1 Election Act

1 *The Election Act is amended by this Part.*

2 *Section 1 is amended*

(a) *by repealing clause (c);*

(b) *by adding the following after clause (k.01):*

(k.02) "multi-municipality electoral division" means the
following electoral divisions established by the
Electoral Divisions Act:

Explanatory Notes

Part 1 Election Act

1 Amends chapter E-2 of the Revised Statutes of Alberta 1980.

2 Section 1 presently reads in part:

1 In this Act,

(c) "city electoral division" means the following electoral divisions as described in the Schedule to the Electoral Divisions Act:

(r) "rural electoral division" means any electoral division described in the Schedule to the Electoral Divisions Act that is not a city electoral division;

3 Section 18 is amended

- (a) in subsection (1) by striking out “city” and substituting “single municipality”;*
- (b) in subsection (2) by striking out “rural” and substituting “multi-municipality”.*

4 Section 26(1) is amended

- (a) in clause (a) by striking out “city” and substituting “single municipality”;*
- (b) in clause (b) by striking out “rural” wherever it occurs and substituting “multi-municipality”.*

3 Section 18(1) and (2) presently read:

18(1) The returning officer shall appoint as enumerators for each subdivision of a city electoral division 2 electors resident in that electoral division.

(2) The returning officer shall appoint as enumerator for each subdivision of a rural electoral division one elector resident in that electoral division but may, if he considers it necessary, appoint a second resident elector for a subdivision.

4 Section 26(1) presently reads:

26(1) On or before September 30 the enumerator shall prepare for his subdivisions a complete list of names of those persons indicated by the enumeration to be qualified electors, organized

(a) for a city electoral division, by geographical arrangement in order of streets, avenues and like designations, and including complete residential addresses and postal codes, and

(b) for a rural electoral division,

(i) by alphabetical arrangement of surnames, and

5(1) The general enumeration for the year 1993 may be conducted during a period determined by the Select Standing Committee on Legislative Offices that is earlier than the period set out in section 14 of the Election Act.

(2) If an earlier enumeration period is determined under subsection (1),

(a) the dates or periods for the doing of the things referred to in sections 15, 16(3), 26, 29, 33 and 34 of the Election Act are to be determined by the Select Standing Committee on Legislative Offices,

(b) the date for determining a person's eligibility under section 23 of the Election Act is the day after the last day of the enumeration period, and

(c) the period of revision consists of the Thursday, Friday and Saturday of the 2nd full week following the end of the enumeration period.

Part 2 Electoral Boundaries Commission Act

6 The Electoral Boundaries Commission Act is amended by this Part.

7 Section 5 is repealed and the following is substituted:

**Appointment
of new
Commissions**

5(1) In this section, "decennial census" means a decennial census of population referred to in section 19(3) of the *Statistics Act* (Canada).

(2) Commencing with the next decennial census, there is to be a new Commission after each decennial census.

(3) A new Commission is to be appointed as soon as possible after the population count for the electoral divisions, as ascertained by the decennial census, is available.

(ii) in the case of

(A) a city,

(B) a town that has residential addresses, or

(C) a hamlet that has a population in excess of 10 000 persons,

that is contained in a rural electoral division, by geographical arrangement in order of streets, avenues and like designations, and including complete residential addresses and postal codes.

5 1993 enumeration.

Part 2

Electoral Boundaries Commission Act

6 Amends chapter E-4.01 of the Statutes of Alberta, 1990.

7 Section 5 presently reads:

5(1) A new Commission shall be appointed during the first session of the Legislature following every 2nd general election after the appointment of the last Commission.

(2) Notwithstanding subsection (1), if less than 8 years has elapsed since the appointment of the last Commission, a new Commission shall be appointed

(a) no sooner than 8 years, and

(b) no later than 10 years

8 *Section 7(1) is repealed and the following is substituted:*

Public
hearings

7(1) The Commission must hold public hearings both

- (a) before its report is submitted to the Speaker, and
- (b) after its report has been made public,

at the places and times it considers appropriate to enable representations to be made by any person as to the area and boundaries of any proposed electoral division.

9 *Section 11 is repealed.*

10 *Section 12(d) is repealed and the following is substituted:*

- (d) “population” means the population of Alberta as provided in the most recent decennial census of population available under the *Statistics Act* (Canada), plus the population on Indian reserves that were not included in the census, as provided by the Department of Indian and Northern Affairs (Canada).

11 *Sections 14 and 15 are repealed and the following is substituted:*

14 There are to be 44 proposed single municipality electoral divisions as follows:

- (a) 20 electoral divisions entirely within The City of Calgary;
- (b) 18 electoral divisions entirely within The City of Edmonton;

after the appointment of the last Commission.

8 Section 7(1) presently reads:

7(1) The Commission

(a) may before its report is submitted to the Speaker, and

(b) shall after its report has been made public,

hold public hearings at the places and times it considers appropriate to enable representations to be made by any person as to the area and boundaries of any proposed electoral division.

9 Section 11 presently reads:

11 After the results of each census under the Statistics Act (Canada) become available, the Chief Electoral Officer shall submit a report to the Speaker indicating those electoral divisions that no longer comply with section 17 and the extent of the non-compliance.

10 Section 12 presently reads:

12 In this Part,

(a) "multi-municipality electoral division" means a multi-municipality electoral division referred to in section 15;

(b) "municipality" includes, for the purposes of this Part, a Metis settlement and an Indian reserve;

(c) "single municipality electoral division" means an electoral division that consists only of part of or the whole of one municipality;

(d) "population" means the population of Alberta as determined by the most recent census available under the Statistics Act (Canada) at the time a Commission is appointed.

11 Sections 14 and 15 presently read:

14 There shall be 43 proposed single municipality electoral divisions as follows:

(a) 19 electoral divisions entirely within The City of Calgary;

(b) 17 electoral divisions entirely within The City of Edmonton;

(c) 2 electoral divisions entirely within The City of Lethbridge;

- (c) 2 electoral divisions entirely within The City of Lethbridge;
- (d) one electoral division entirely within The City of Medicine Hat;
- (e) one electoral division entirely within The City of St. Albert;
- (f) one electoral division entirely within The City of Fort McMurray;
- (g) one electoral division entirely within The County of Strathcona that includes the hamlet of Sherwood Park as set out in an order of the Minister of Municipal Affairs numbered M.O. 700/84.

15 There are to be 39 proposed multi-municipality electoral divisions as follows:

- (a) 2 electoral divisions consisting of
 - (i) part of The City of Red Deer, and
 - (ii) all or part of one or more other municipalities,with all of that City being included in those 2 electoral divisions;
- (b) one electoral division consisting of
 - (i) the part of The City of Medicine Hat not included in a single municipality electoral division under section 14, and
 - (ii) all or part of one or more other municipalities;
- (c) 2 electoral divisions, each consisting of
 - (i) part of The City of Grande Prairie, and
 - (ii) all or part of one or more other municipalities,with all of that City being included in those 2 electoral divisions;
- (d) 34 electoral divisions consisting of
 - (i) more than one municipality,

- (d) one electoral division entirely within The City of Medicine Hat;*
- (e) one electoral division entirely within The City of Red Deer;*
- (f) one electoral division entirely within The City of St. Albert;*
- (g) one electoral division entirely within The City of Fort McMurray;*
- (h) one electoral division entirely within The County of Strathcona that includes the hamlet of Sherwood Park.*

15 There shall be 40 proposed multi-municipality electoral divisions as follows:

- (a) one electoral division consisting of*
 - (i) the part of The City of Red Deer not included in a single municipality electoral division under section 14, and*
 - (ii) all or part of one or more other municipalities;*
- (b) one electoral division consisting of*
 - (i) the part of The City of Medicine Hat not included in a single municipality electoral division under section 14, and*
 - (ii) all or part of one or more other municipalities;*
- (c) one electoral division consisting of*
 - (i) the part of The City of St. Albert not included in a single municipality electoral division under section 14, and*
 - (ii) all or part of one or more other municipalities;*
- (d) 2 electoral divisions, each consisting of*
 - (i) part of The City of Grande Prairie, and*
 - (ii) all or part of one or more other municipalities,*

with all of that City being included in those 2 electoral divisions;
- (e) 35 electoral divisions consisting of*
 - (i) more than one municipality,*
 - (ii) one or more municipalities plus parts of one or more other municipalities, or*

- (ii) one or more municipalities plus parts of one or more other municipalities, or
- (iii) parts of more than one municipality.

12 Section 16 is amended by adding the following after clause (c):

- (c.1) wherever possible, the existing community boundaries within the cities of Edmonton and Calgary,
- (c.2) wherever possible, the existing municipal boundaries,

13 Section 17(2) and (3) are repealed and the following is substituted:

(2) Notwithstanding subsection (1), in the case of no more than 4 of the proposed electoral divisions, if the Commission is of the opinion that at least 3 of the following criteria exist in a proposed electoral division, the proposed electoral division may have a population that is as much as 50% below the average population of all the proposed electoral divisions:

- (a) the area of the proposed electoral division exceeds 20 000 square kilometres or the total surveyed area of the proposed electoral division exceeds 15 000 square kilometres;
- (b) the distance from the Legislature Building in Edmonton to the nearest boundary of the proposed electoral division by the most direct highway route is more than 150 kilometres;
- (c) there is no town in the proposed electoral division that has a population exceeding 4000 people;

(iii) *parts of more than one municipality.*

12 Section 16 presently reads:

16 In determining the area to be included in and in fixing the boundaries of the proposed electoral divisions, the Commission, subject to section 17, may take into consideration any factors it considers appropriate, but shall take into consideration

- (a) the Canadian Charter of Rights and Freedoms,*
- (b) sparsity and density of population,*
- (c) common community interests and community organizations, including those of Indian reserves and Metis settlements,*
- (d) the number of municipalities and other local authorities,*
- (e) geographical features, including existing road systems, and*
- (f) the desirability of understandable and clear boundaries.*

13 Section 17(2) and (3) presently read:

(2) Notwithstanding subsection (1), in the case of no more than 5% of the proposed electoral divisions, if the Commission is of the opinion that at least 4 of the following criteria exist in a proposed electoral division, the electoral division may have a population that is as much as 50% below the average population of all the electoral divisions:

- (a) the area of the proposed electoral division exceeds 20 000 square kilometres;*
- (b) the total surveyed area of the proposed electoral division exceeds 15 000 square kilometres;*
- (c) the total length of primary and secondary highways within the proposed electoral division exceeds 1000 kilometres;*
- (d) the distance from the Legislature Building in Edmonton to the nearest boundary of the proposed electoral division by the most direct highway route is more than 150 kilometres;*
- (e) there is no town in the proposed electoral division that has a population exceeding 4000 people;*

- (d) the area of the proposed electoral division contains an Indian reserve or a Metis settlement;
 - (e) the proposed electoral division has a portion of its boundary coterminous with a boundary of the Province of Alberta.
- (3) For the purpose of subsection (2)(c), The Municipality of Crowsnest Pass is not a town.

Part 3 Electoral Divisions Act

14 The Electoral Divisions Act is amended by this Part.

15 Section 1 is repealed and the following is substituted:

Purpose of Act

1 The electoral divisions for the purposes of the *Election Act* are the 83 electoral divisions established by this Act.

(3) For the purpose of subsection (2)(e), The Municipality of Crowsnest Pass is not a town.
