MOST GRACIOUS SOVEREIGN:

Preamble

WHEREAS it appears by a Message from His Honour, Gordon Towers, Lieutenant Governor of the Province of Alberta, and the Schedule accompanying the Message, that the sum hereinafter mentioned is required during the fiscal year ending March 31, 1994 for the purpose of the making of investments pursuant to section 6(1)(a) of the Alberta Heritage Savings Trust Fund Act in projects which will provide long term economic or social benefits to the people of Alberta but which may not necessarily by their nature yield a return to the Alberta Heritage Savings Trust Fund:

MAY IT THEREFORE PLEASE YOUR MAJESTY that it be enacted and be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Alberta, as follows:

Appropriation for 1993-94

1 From and out of the Alberta Heritage Savings Trust Fund, there may be paid and applied a sum not exceeding \$69 186 100 for the period from April 1, 1993 to March 31, 1994 for the purpose of making investments in projects which will provide long term economic or social benefits to the people of Alberta but which may not necessarily by their nature yield a return to that Fund, being the aggregate of the amounts enumerated in Schedule "A" and including \$55 384 844 provided by interim supply special warrant as set forth in Schedule "B".

Accountability 2 The due application of all money expended under this Act shall be accounted for.
