Crop Liens Priorities Act

Amends RSA 1980 cC-34

10 Section I(a) of the Crop Liens Priorities Act is repealed.

Dairy Industry Act

Amends SA 1981 cD-1.1 11 Section 1(i) of the Dairy Industry Act is amended by striking out "as defined in the Margarine Act" and substituting "that conforms to Division 9 of Part B of the Food and Drug Regulations (Canada) (CRC, Vol. VIII c.870)".

Seed Grain Purchase Act

7 Repeals chapter S-10 of the Revised Statutes of Alberta 1980.

Threshers' Lien Act

8 Repeals chapter T-4 of the Revised Statutes of Alberta 1980.

Western Irrigation District Agreement Act, 1954

9 Repeals chapter 111 of the Statutes of Alberta, 1954.

Crop Liens Priorities Act

- **10** Amends chapter C-34 of the Revised Statutes of Alberta 1980. Section 1(a) presently reads:
 - 1 Notwithstanding anything in any Act or in the common law, the following liens and charges on crops have, in the order hereinafter set out, priority over all other claims, liens, privileges or encumbrances on those crops:
 - (a) the threshers' lien under the Threshers' Lien Act for threshing the crops;

Dairy Industry Act

- 11 Amends chapter D-1.1 of the Statutes of Alberta, 1981. Section 1(i) presently reads:
 - 1 In this Act,
 - (i) "imitation dairy product" means any food substance other than a dairy product, of whatever origin, source or composition, that is manufactured
 - (i) wholly or in part from a fat or oil, other than that of milk,
 - (ii) for human consumption, and
 - (iii) for the same or a similar use as, and in semblance of, a dairy product,

but does not include margarine as defined in the Margarine Act or any product intended for use as a dessert topping, coffee whitener or infant formula;

Metric Conversion Amendment Act

Amends RSA 1980 c12 (Supp.)

12(1) The Metric Conversion Amendment Act is amended by this section.

- (2) Section 1(5) is repealed.
- (3) Section 1(17) is repealed.
- (4) Section 1(22) is repealed.

Public Lands Act

Amends RSA 1980 cP-30

13 Section 64(3) of the Public Lands Act is repealed.

School Amendment Act, 1993

Amends SA 1993 c24

14 The School Amendment Act, 1993 is amended in section 3, in the portion of it that adds a new section 2.1(7) to the School Act, by striking out "Crown Cultivation Leases Act;".

Metric Conversion Amendment Act

- 12(1) Amends chapter 12 (Supp.) of the Revised Statutes of Alberta 1980.
- (2) Repeals section 1(5) of the Metric Conversion Amendment Act, which has never been proclaimed in force and which amends the Beet Lien Act.
- (3) Repeals section 1(17) of the Metric Conversion Amendment Act, which has never been proclaimed in force and which amends the Margarine Act.
- (4) Repeals section 1(22) of the Metric Conversion Amendment Act, which has never been proclaimed in force and which amends the Threshers' Lien Act.

Public Lands Act

- **13** Amends chapter P-30 of the Revised Statutes of Alberta 1980. Section 64(3) presently reads:
 - (3) In so far as they affect a crop share cultivation lease granted under the former Act or The Provincial Lands Act, the provisions of this section are subject to section 4 of the Crown Cultivation Leases Act.

School Amendment Act, 1993

- 14 Amends section 3 of chapter 24 of the Statutes of Alberta, 1993, which has not yet been proclaimed in force. This adds a new section 2.1(7) to the School Act, partly reading as follows:
 - 2.1(7) Subsection (6) does not apply to a reference in the following Acts:
